PROJECT OUTLINE项目介绍

- **Location: West Coast, New Zealand 地点：新西兰西海岸**
 - **Contains a total area of 3971 hectares (9808.37 Acre/39,710,000 square meters) of permitted area spread across 4 different permits. 金矿可开采区域占地3971公顷（9808.37 英亩/39,710,000平方米），分布在4个不同矿区。**
 - **The extraction is targeted at the alluvial (placer) gold bearing gravels that is concentrated in deposits across the operation area. 开采目标是集中在整个运营区域的沉积物中的冲积层（砂砾）含金砾石。**

CONSENTING AND PERMITTING AUTHORITY

同意和许可授权

- **Mineral permitting is administered by New Zealand mineral and petroleum (NZPAM) under Crown Minerals Act 1991.** 根据1991年《皇家矿产法》，矿产许可由新西兰矿产和石油（NZPAM）管理。
 - **Two Mining Permits.** 两处采矿许可证。
 - **Two Exploration Permits.** 两处勘探许可证。
 - **Long term access agreement secured with Land owners (approx 30 percent of permitted area). With all remaining landowners open to negotiation or buyouts.** 可与土地所有者签订长期准入协议（约占矿区面积的30%）。所有剩余的土地所有者都愿意进行谈判或收购。

PERMIT 1

➤ South 南区

- **Preliminary mining has been conducted and feasibility assessed.** 初步采矿已经进行，可行性评估已经完成。
- **An initial pit area of 4,000 square meters and an average depth of 25 meters was excavated and processed. The average gold yield of 0.15 grams per cubic meter of material processed.** 挖掘和处理后，初始坑面积为**4000**平方米，平均深度为**25**米。每立方米矿料的平均黄金产量为**0.15**克。
- **Pit test shows a continuation of mineral-rich deposits towards the east of the mine site.** 矿井测试显示，矿址以东连续存在富含矿物质的矿床。
- **Next Stage would involve the continuation of testing along the deposit area and finishing the construction of the processing plant and procurement of excavation equipment.** 下一阶段将包括继续沿矿床区域进行测试，完成加工厂的建设和挖掘设备的采购。

➤ North 北区

- **The existing processing plant was constructed, and testing was conducted around the surrounding area. Gold was discovered on the surface level, ~6-7 meters.** 现有的加工厂已经建成，并在周边地区进行了测试。在地表上发现了黄金，大约**6-7**米。
- **The next stage would focus on deep-level testing and full commissioning of processing plant.** 下一阶段重点将在加工厂的深度测试和全面调试。

PERMIT 2 矿区 2

- **Testing was conducted throughout the claim area, with a mix of hole and pit tests.** 在整个矿区进行了测试，包括打孔和矿坑测试。
 - **All hole test were conducted to a depth of 8 meters with significant mineralisation throughout the claim.** 所有孔洞测试都是在8米深进行的，整个矿区都有明显的矿化。
 - **Multiple pit tests shows material with 0.15-0.2 grams of gold per cubic meter of washed processed.** 多次坑测试显示，每立方米水洗法处理的矿料中含有0.15-0.2克黄金。
 - **Preliminary Pit test processed roughly 4000 cubic meter of material from a depth of 4-5 meters shows mineralisation of approx 0.12g, Pit tests also shows adequate water supply to support full scale mining.** 初步矿井测试从4-5米深度处理了约4000立方米的矿料，显示矿化约为0.12克，矿坑测试还显示有足够的水源来支持全规模采矿。
 - **The next stage would involve establishing a trial processing facility and the supporting equipment.** 下一阶段将建立一个试验处理设施和配套设备。

PERMIT 3

- **Early stage exploration with hand panning and hole testing. Gold was discovered on the surface level (approx 4 meters).** 在早起勘探阶段使用手工淘洗和开孔测试。在地表（约4米）发现了黄金。
 - **The next stage would require more exploration testing along the eastern corner of the permit area where trends shows mineralisation from Permit 1 might be connected with.** 下一阶段将需要沿着矿区的东角进行更多的勘探测试，趋势显示矿区1的矿化可能与之相关。

PERMIT 4

- **Permit area in early stages of development. Historical data shows large scale dredging has occurred towards the southern corner of permit. Mineralisation is highly probable given the trends and data collected from previous permit areas.** 矿区处于早期开发期。历史数据显示，向矿区的南角进行了大型的挖掘。鉴于从以前的矿区收集的趋势和数据，矿化的可能性很高。
 - **Next stage would involve exploring the eastern sections of the claim where data indicates an old riverbed may exist connecting with existing wash channels.** 下一阶段将开发矿区的东部，数据表明可能存在与现有淘洗通道相连的旧河床。
