Governed AI Agents That Security Approves

The Challenge

Teams want to deploy AI assistants to draft reports, look up data, and automate small operational tasks.

Security and Compliance teams block progress: raw database access was prohibited, audit trails were missing, and ungoverned “shadow bots” were appearing across departments. Result innovation stalled and risk increased.

Our Solution

Governed AI Runtime: a secure on-prem/VPC platform where every agent action runs under user-level RBAC and policy-based approvals.

Immutable Audit Log: all prompts, outputs, and actions are time-stamped and checksum-verified for audit.

Guardrailed Adapters: approved data-access layers ensure agents can only read/write what policies permit.

Templates for Speed: starter agents for report drafting, data lookups, and configuration changes reuse the same controls.

- Security-cleared AI in production without exceptions
- Faster internal tool delivery (↑ throughput / ↓ ticket backlog)
- Reduced manual ops hours and shadow-IT risk
- Audits passed on first attempt with full traceability

Late or out-of-order data feeds led to re-processing and audit delays.

Deterministic pipelines replayed late data for a single source of truth.

Immutable logs recorded every transaction for full traceability.

- Reduced compute costs and mitigated variance risks.
