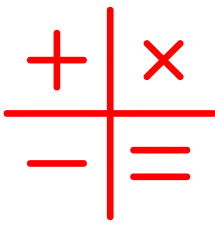
Monitor

Proactively mitigate identified vulnerabilities and threats through penetration testing, cyber threat intelligence, advanced AI enabled security analytics and hybrid assessments



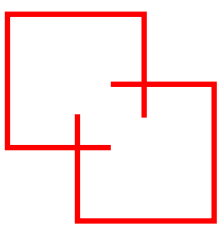

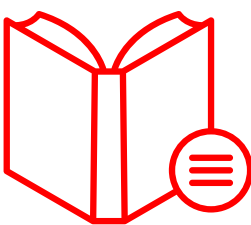
