



### Revenue Streams

#### Onboarding Fee

\$3,000-\$50,000 per deal

#### Value-Added Services

Referrals, premium services, subscriptions

#### Capital Raise Fee

4-7% depending on deal size

#### Platform & AUM Fees

30% platform fee, 1% of AUM (2027)






Initial Pipeline: \$3.5M raise generating \$175K revenue in first 6 months
