11 EXECUTIVE SUMMARY

Cosmixio bridges Space Science, Web3, and Sustainable Finance to create the trust infrastructure of the global orbital economy.

It verifies, secures, and tokenizes satellite-derived data using blockchain and Al - transforming information into verifiable digital assets that governments, investors, and institutions can trust and monetize.

Cosmixio operates as a federated-to-decentralized hybrid, combining the compliance of centralized systems with the scalability of Web3.

The platform is designed to align technological innovation with the UN Sustainable Development Goals (9, 13, and 17), ensuring global inclusion and sustainability.

2 PROBLEM

- 60 % of orbital data cannot be independently verified or monetized.
- The current satellite data economy is fragmented, untraceable, and nonauditable.
- ESG and institutional investors lack a trusted proof-of-integrity layer for orbital data.
- Without verifiable infrastructure, the trillion-dollar space economy remains inefficient and siloed.

3 SOLUTION — COSMIXIO TRUST LAYER

Federated Infrastructure (Phase I)

Founder-led, regulatory-compliant network linking national and private space operators under unified standards.

Decentralized Expansion (Phase II)

Gradual evolution into a global multi-node ecosystem where each partner becomes a secure space-data authority.

Core Functions

- 1. Proof of Space Data: Onboard hashing + ground validation + blockchain anchoring.
 - 2. OrbFi Network: Converts verified space data into digital financial assets.
 - 3. Al & Analytics: Automated validation, ESG tracking, and asset scoring.
 - 4. Compliance Engine: Meets ESA, EU Al Act, and ISO 27001 frameworks.
