



Limited (ACN 616 130 913) acting an Australian Financial Services Authorised Representative (Number 001277503) of Wealth Pi Capital Pty Ltd (ACN 052 435 079) as Manager of the WealthPI Trust (Issuer) (Investment Memorandum).

This independent verification report is issued in accordance with the reporting provision set out in Description of the Trust Investments of the Investment Memorandum.

AMAL Security Services Pty Ltd (ACN 609 790 758) in its capacity as Verification Agent for the Wealth Pl Trust (AMAL) has undertaken an independent verification for the WealthPl Trust and confirms that as at 31 December 2022 it has reviewed the primary source documents confirming the following:



Milestones of Wealth Pi Bond Issuance & Mandate establishment

Wealth Pi Fund started a precedent as one of the first property funds that issued bonds backed by first mortgage security through ASX Austraclear system. The bonds are structured with security trustees and other backup roles in place and highly sought after by the investment institutions.



April 2018

WPF issued the first bond at the value of \$6M regarding a construction loan secured by first mortgage, which was successfully repaid on time at the end of March 2019.

July 2018

WPF issued a bond at the value of \$7.2M regarding a land loan secured by first mortgage, which was successfully repaid on time at the end of October 2019.

July 2019

WPF issued a bond at the value of \$7M regarding a land loan secured by first mortgage, which was successfully repaid on time in July 2021.

August 2019

WPF issued a bond at the value of \$15.95M regarding a land loan secured by first mortgage, which was successfully repaid in August).

July 2021

WPF issued a 5-year bond at the value of up to \$150 million regarding a pool of first mortgage real estate commercial loans.




