

## Terms of participation – Health Revolution Congress (HRC) 2026 Open Innovation Challenge

By registering for the **Health Revolution Congress (HRC) 2026 Open Innovation Challenge** you accept the following terms, conditions, and privacy statement:

1. Have a company VAT-No. Proposals from self-employed people are not accepted.
2. Should NOT merely be a consultancy/agency or developing software/apps only for others. Should not be just a website/landing page that lacks activity either. Should NOT be for those that do not have a specific solution / development for the challenges presented. e.g. natural persons (individuals).
3. Only 1 participant per organization can be registered in the platform. Nevertheless, during the meetings more than one person per company is allowed.
4. Your profile will only be published once you fulfil all the registration steps/requirements.
5. Challenge owners are required to publish at least one opportunity (collaboration profile) outlining the challenge.
6. Tech providers must provide in their company profile a detailed description of their products, services, or expertise in response to the challenges listed on the platform.
7. Cancellations will only be managed through the platform, in this way, the other participant and the organizers will be automatically notified, and the schedule will be always updated. Failure to do so may exclude you to participate in future Brokerage Events to avoid any further inconveniences to other participants.
8. The organizers reserve the right to give your personal contact details to the participants with whom you have booked a meeting in accordance with our privacy policy, which allows us to transfer that data because is an indispensable part of these activities and/or services, which is based on the contractual relationship between the participants and ACCIÓ.
9. The feedback of your participation is required under this activity. Therefore, you are asked to notify any collaboration agreements that you reach with other participants to the organizer. This information will be treated confidentially.
10. Participants must inform the organizers about the meetings with other participants even if they are held outside the Health Revolution Congress (HRC) 2026 Open Innovation Challenge.
