





# what we do



## how it works



The Green Threads Digital Product Passport will constitute the following elements

#### **Factory credentials**

The sustainability credentials for the factory of origin for a given product.

### Ongoing performance

The commitment to and ongoing performance against pre-described science based targets of the factory in question. (Accumulating data and scoring performance

#### **Carbon characteristics**

The embodied carbon characteristics of the specific product in question.

#### **Certified credentials**

The certified credentials relating to social and corporate governance of the factory in question.

5

### Recyclable qualities

Recycling guidelines and disposal information.



#### **Product composition**

The composition of the product in question including use of recycled materials, recycling guidelines and disposal information.

#### Full lifecycle traceability

The dpp will also be capable of facilitating full lifecycle traceability as part of the evolution of its functionality.
