TOURNAMENT CHECK-IN / BRIEFING DATE	May 19	REGISTRATION REMINDER: All anglers must CHECK-IN in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. You will be fined for being late.

OFFICIAL PRACTICE DAYS	May 16 - 18 . ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS on May 19. During official practice, competitors may only fish with other competitors per Rule 3ii.	
PRE -TOURNAMENT OFF-LIMITS	Off-limits will begin on Saturday April 18, and extend through Saturday May 16@ safelight. During this time you are not allowed on tournament waters.	
TOURNAMENT WATERS	Tournament waters will be Kentucky and Barkley Lakes and all rivers, creeks and canals connected to those waters. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. No locking will be permitted. Tennessee waters on Barkley Lake will be off limits.
