TOURNAMENT CHECK-IN / BRIEFING DATE	March 31, 2026 REGISTRATION REMINDER: All anglers must CHECK-IN in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. You will be fined for being late.

OFFICIAL REGISTRATION / ON SITE CHECK-IN	2:00 pm to 4:20 pm via Time slots. Time slots will be emailed tournament week.
TOURNAMENT BRIEFING	Virtual - All Contestants must view.
OFFICIAL PRACTICE DAYS	March 28-30. ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS on March 31. During official practice, competitors may only fish with other competitors per Rule 3ii.
PRE -TOURNAMENT OFF-LIMITS	Off-limits will begin on Saturday Feb. 28 and extend through Saturday, March 28 @ safelight. During this time you are not allowed on tournament waters.
TOURNAMENT WATERS	Tournament waters will be Lake Eufaula and any creeks and canals connected to Lake Eufaula. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. No Locking
FISHING LICENSE	Alabama is required. Online: https://www.outdooralabama.com/licenses/freshwater-fishing-licenses ** Georgia License is also accepted
FISH LIMITS	Pro-Angler: 5 fish / Co-Angler: 3 fish / 14" minimum length
