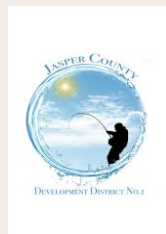

| TOURNAMENT CHECK-IN / BRIEFING DATE | February 18, 2026 REGISTRATION REMINDER: All anglers must CHECK-IN in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. You will be fined for being late. |
| WEDNESDAY ACTIVITIES LOCATION | Umphrey Family Pavilion |
| OFFICIAL REGISTRATION / ON SITE CHECK-IN | 10:00 am to 3:00 pm via Time slots. Onsite in person briefing and vessel electronic inspection will take place. |
| TOURNAMENT BRIEFING | Mandatory in person immediately following check-in |
| OFFICIAL PRACTICE DAYS | February 15-17. ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS on Feb. 18. During official practice, competitors may only fish with other competitors per Rule 3ii. |
| PRE -TOURNAMENT OFF-LIMITS | Off-limits will begin on Sunday January 18 th and extend through Sunday, February 15 th @ safelight. During this time you are not allowed on tournament waters. |
| TOURNAMENT WATERS | Sam Rayburn Reservoir and all rivers, creeks and canals connecting to Sam Rayburn. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. |

| FISH LIMITS | Pro-Angler: 5 fish 14-inch minimum length |

Balance deadline dates are the dates the balances are due. You will not receive any further notices on balance due. It is the anglers' responsibility to be sure payment is made by the deadline date.
