Addendum A

General Rules

- **5. Outdoor Fire Restrictions**
 - a. Burning in incinerators is prohibited.
 - b. All fireworks, rockets, canons and other incendiary devices are prohibited.
 - c. Open fires within Big Elk Meadows are prohibited except for barbeque grills and patio fireplaces. No open fires are permitted off decks or patios.
 - d. Devices using gas, jellied petroleum, pressurized liquid fuel that do not have a shut-off switch are prohibited.
 - e. Charcoal grill should be on a flat noncombustible or fire resistive surface.
 - f. Wood may be used to enhance cooking in grills or smokers. g. Outdoor wood fires are prohibited for short-term guests.
 - h. Outdoor wood fires are prohibited, except
 - 1. In permanently constructed, stationary, masonry or metal fire pits specifically designed for the purpose of combustion, including a spark arrester.
 - 2. In commercially constructed fire pits inclusive of a spark arrester.
