SUBSCRIPTION AGREEMENT

Wine Valet Pty Ltd, ABN: 78 630 866 634 (the **Company**)

Wine Valet Pty Ltd CSF Offer (under CSF Offer document dated 02/06/2021) (the **Offer**)

By applying for shares in the Company under the Offer (**Shares**), you (the **Subscriber**) and the Company (together the **parties**) agree to the following terms and conditions (the **Subscription Agreement**).

Birchal Financial Services Pty Ltd ABN 39 621 812 646 AFSL 502 618 (**BFS**) and Birchal Pty Ltd ACN 616 478 767 (**Birchal**) are not parties to this Subscription Agreement.

This Subscription Agreement, the Constitution of the Company, BFS Investor Terms and the CSF Offer Document govern the terms and conditions on which you (the **Subscriber**) agree to subscribe for shares in the Company.

This Subscription Agreement is intended to be legally binding, and the parties agree to give effect to the transactions and arrangements contemplated by it.

Application and subscription price

The Subscriber must apply and pay for shares via the crowd sourced funding platform operated by BFS, located at www.birchal.com in respect of the Offer (the **Application Facility**).

Issue of subscription shares

The Company represents and warrants to the Subscriber that:

- As soon as possible after the successful completion of the Offer, the Company will allot and issue the Shares to the Subscriber, and provide the Subscriber with evidence of the issue of the Shares, and information about how the Subscriber can view the share register.
