Affiliates must earn a minimum of P5,000 or more before their account is eligible for payment. Commissions will be deposited on their given bank accounts so make sure that you have updated the bank account details in your profile page.

Commission amounts earned for less than P5,000 will remain pending until P5,000 minimum balance has been earned.
