

## Immigration Wing, FIA Headquarters, Islamabad

**Business Visa on Arrival (Single Entry 30 Days)** is being issued to businessmen from Pakistan's business-friendly countries. Please talk to one of the Immigration Officers or the designated Visa Officer on arrival. You will be required to produce one of the following documents and pay fee as below.

1. Letter of Invitation from a business organization in Pakistan with recommendation letter from a Chamber of Commerce in Pakistan.
2. Letter of Invitation from a business organization in Pakistan with recommendation letter from a Trade Association in Pakistan.
3. Letter of Recommendation from an Investment Counsellor or Commercial Attaché in Pakistan's Mission Abroad.
