**RELEASE AND WAIVER
BROWN UNIVERSITY - MODEL UNITED NATIONS**

I, the undersigned, will be attending the Brown University Simulation of the United Nations ("Event"), an annual high school conference sponsored by Brown's Model United Nations ("BMUN") at Brown's campus in Providence, Rhode Island ("Site") from November 9, 2018 through November 11, 2018. The purpose of the Event is for high school students from around the country, and their advisors, to engage in a mock United Nations experience, and to participate in a delegate social on the evening of Saturday, November 10, 2018 ("Social").

On November 9, 2018, participants in the Event will be departing from their respective hotels* (*refer to hotel list on page 3*) via shuttle bus transportation provided by First Student, Inc. ("First Student") (running on half-hour loops to accommodate the varied arrival times of participants) to the Brown campus to attend conference and committee sessions until 10:30 PM. Event participants will return to their respective hotels via transportation provided by First Student with shuttle runs leaving the Brown campus at 10:45 PM and 11:15PM.

On November 10, 2018, Event participants will be departing from their respective hotels via transportation provided by First Student with morning pickups at 8:00 AM and 8:30 AM to return to the Brown campus for a day of conference and committee sessions running until 6:00 PM. Event participants will return to their respective hotels via transportation provided by First Student with shuttle runs leaving the Brown campus at 6:15 PM and 6:45 PM. Event participants will depart from their respective hotels via transportation provided by First Student with shuttle runs at 7:15 PM, 7:45 PM, and 8:15 PM to attend the Social at Brown's Sayles Hall. Transportation will be provided by First Student with shuttles leaving from Brown's Sayles Hall at 9:15 PM, 9:45 PM, and 10:15 PM to return Event participants to their respective hotels.

On November 11, 2018, Event participants will be departing from their respective hotels via shuttle bus transportation provided by First Student with morning pickups at 8:00 AM, 8:30 AM, and 9:30 AM to return to the Brown campus for closing ceremonies.

I understand that during the period that I am not attending the Event, any activities in which I engage (including but not limited to travel) are not under the auspices of Brown. I acknowledge that I am voluntarily attending the Event and understand that my attendance is subject to any and all rules, procedures, and regulations of the Event as outlined for me by the Event organizer. I understand that attendance is not required for successful completion of any course and acknowledge that I have been advised that any decision not to attend the Event will not have any impact on my evaluation or grade in any course. I also acknowledge that permission granted to me to participate in the Event shall be revocable at any time, either before or during the Event, if deemed by Brown University personnel and/or any other person acting in a supervisory capacity to be in my best interest or in the best interests of other participants in the Event.

In consideration of my being permitted to attend the Event, I do hereby release, indemnify, and forever discharge Brown University, including the Corporation, its Trustees, faculty, employees, staff, and other agents from and against (i) any and all liability and responsibility for any claim or cause of action on account of any personal injury, accident, damage, expense, or other loss caused, suffered, or incurred by me or any other person(s) or entity during, arising out of, or in any way associated with, directly or indirectly, my participation in the Event (including but not limited to travel incidental thereto), and (ii) from contribution or indemnification with respect to any claim made against me by any other participant of the Event or any other person or entity in connection therewith.

I understand that even under the safest conditions possible there are hazards and inherent risks involved in the Event, including the activities associated therewith and travel incident thereto, which may result in personal injury (including but not limited to bumps, bruises, muscle sprains, strains, foodborne illness) or death. I voluntarily agree to assume the risks of any and all personal injury to me and/or loss or damage to my personal property. I understand that Brown

assumes no responsibility for the actions of any participants of the Event, or of any other persons or service providers. I further acknowledge that Brown bears no responsibility or liability for any claims or causes of action that I may have or that any other person may have against me for my participation in the Event.

I acknowledge that I have read and understood the above statements and that I am at least 18 years old and of legal age to bind myself to this Release and Waiver. If I am not at least 18 years old, I have secured the signature of my parent(s) or legal guardian(s) on this Release and Waiver, who, by signing, agree to be bound by all of its terms and conditions. This Release and Waiver has been executed on behalf of myself, my heirs and assigns, and has been made with full knowledge of possible risks involved.
