Camp Goals

To provide an opportunity for young people to experience the outdoors and connect with the natural world, learn skills, build self-esteem and practice developing constructive social relationships in a safe healthy environment.

Specific Responsibilities

Nanny position

- Ensure the safety, wellness, and hygiene of assigned children (ages 1-5)
- Encourage the development of the children throughout the day by playing with them, singing, encouraging physical development (skipping, running, jumping, climbing), talking to them, reading books, doing puzzles, going on nature walks, doing crafts etc.
- Prepare and plan new and interesting daily activities, but allow for child-led activity selection
- Assist children with meals and snacks collaboratively with parents. Allow for breastfeeding with mother as needed. Be able take children out of the Dining Hall to play when meal is complete.
- Keep children clothed appropriately and clean/bathe them if needed due to the activities or at parents' request. Be mindful to protect from sun and bugs as best as possible with appropriate clothing and/or products.
 - Change diapers and facilitate toilet use as needed throughout the day.
 - Help children keep their play areas tidy, clean, and safe.
 - Communicate openly and honestly with any other care giver and parents.
 - Children may "play" with other pre-approved staff during their off-time. It must be

clearly communicated who is supervising the child. This does not result in "off" time for nanny - continue to supervise, prepare for future activities, or assist with office needs.

• Agree to comply with the child-rearing philosophies of the parents. If there is any ambiguity about what a specific philosophy might be or how a situation should be handled, provider agrees to ask parent.

Activity Specialist (if qualified & program need arises)

- Lead specialty program activities for school-age campers.
- Be aware of and implement safety guidelines and assure campers are properly supervised at all times.
- Participate in the development and implementation of specialty program activities for campers within the mission and outcomes.

General

- Be a role model and set a good example for all campers and staff including cleanliness, punctuality, sportsmanship, and table manners.
- Follow all camp rules.
- Encourage respect for personal property and camp facilities and report repair needs promptly.
- Manage personal time off in accordance with camp policy.
- These are not the only duties to be performed. Some may be reassigned and other duties may be assigned as required.

Essential Functions

- 1. Ability to communicate and work with groups, and provide necessary instruction to campers and staff.
- 2. Physical ability to respond appropriately to situations requiring first aid. Must be able to assist campers in an emergency (fire, evacuation, illness, or injury) and possess strength and endurance required to maintain constant supervision of campers.
- 3. Understand the philosophy and objectives of Camp Natoma, and be able to pass this knowledge on to others.
- 4. Ability to: observe camper behavior; assess it for appropriateness; enforce appropriate safety regulations and emergency procedures; and apply appropriate behavior-management techniques.
- 5. Visual and auditory ability to identify and respond to environmental and other hazards related to camp activities.
- 6. Ability to adapt to rough terrain, heat, and living outdoors.
