#### Dog Registration:

Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee. You may register your dog online at <a href="http://nasda.dog/registration/">http://nasda.dog/registration/</a>. Dogs 6 months of age or older on the date of the test are eligible to compete.

#### Classes:

- Trailing & Locating: Dog follows a scent trail to safely caged live quarry in a natural environment.
- Trailing Brace: Two dogs and handlers in Trailing & Locating.
- Urban Locating: Dog finds safely caged live quarry in human made environments.
- Shed Dog: Dog finds antler sheds in a natural environment. A warm up shed is provided.
- Lost Item Recovery: Dog finds items lost by the handler (Level I) or matches target odor to another person (Level II, III).

#### Awards:

Ribbons are self-serve during the trial. Ribbons are awarded for qualifying score, Best of Breed and High in Class. New Title ribbons will be awarded.

#### Venue:

Exhibitors will be crating from their vehicles or setting up their own canopy. Central Florida K-9 reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog. No concessions on site. Central Florida K-9 is a commercial dog operation with owner residences on site. 30 acres of pasture and canopy coverage, along with a wide variety of fenced training fields. Trailing & Brace will be fenced in areas. Central Florida K-9 is a smoke free property; no smoking or vaping on the property. Commercial kennel operations and residences are off-limits.

#### Notice to Exhibitors:

- Refunds will be mailed 7 days after the event.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such a case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Electronic collars which provide vibration, shock, sound, or spray/chemical corrections are not permitted on trial grounds, however, GPS and location collars are permitted on course.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog and put bags in poop buckets.
- Bitches in season are allowed to run but must run last and wear appropriate pants.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be made payable to **Central Florida K-9**. Online Entries Accepted for a 4% fee added, limited to \$15.
- Central Florida K-9 reserves the right to refuse any entry without cause or explanation.
- All dogs on the grounds are required to be vaccinated and owners agree to furnish proof of vaccinations if requested.
- Check-In begins at 9:30 a.m. with the trial beginning at 11:00 a.m. on Friday. Saturday and Sunday Check-In begins at 7:00 a.m. with the trial beginning at 8:00 a.m.

- All dogs six months of age and older who have not yet earned a title will start in Level I.
- After earning a title in Level I, the dog can progress to Level II and also continue to compete during the same trial for Level I Q's to earn a Level 1 X title.
- Check the Level(s) you want to enter for that day for that class.
- Check each of the trials for each class that you want to enter that day. You can enter none, one, all and any combination for each day/class.
- Urban Challenge Games are offered once per day, per person. Check the Urban Challenge Game to enter:
- 1 Distance, 2 You Make the Call, 3 Elusive Rats, 4 One or None, 5 Silence, 6 Roll of the Dice
