**Family Member/Significant Other Transportation**

- Actual costs up to \$500 per person, Economy Class airfare, including Hotel, Maximum 2 members
- Ground Transportation, actual charges for rental up to \$500

**Missed American Flat Track Events due to injury.**

- Missed American Flat Track Events due to Injury AFT Twins riders will receive \$300 per missed AFT Events due to Injuries that resulted in benefits from us; Maximum 5 events
- AFT Singles riders will receive \$150 per missed AFT Events due to Injuries that resulted in benefits from us; Maximum 3 events

**Catastrophic Injury**

- Life altering or career ending injuries will be individually considered by the Board of Directors for a minimum \$15,000 payment through the Charity general fund in addition to published Schedule of Benefits and special fund raising efforts.
- Special fundraising efforts will be in addition to the Schedule of Benefits payment

**Conditions and notes**

- THE ABOVE SCHEDULE OF BENEFITS IS FOR AFT PROFESSIONAL RIDERS, AND LICENSED PROFESSIONALS. ALL OF THE BENEFITS LISTED WILL BE REDUCED BY 50% FOR AMATEUR LEVEL RIDERS. THE ABOVE SCHEDULE OF BENEFITS IS BASED UPON THE AVAILABLE FUNDING OF THE CHARITY, AND ONLY AVAILABLE AND PAYABLE AS LONG AS THERE ARE SUFFICIENT FUNDS. SINCE OUR INCEPTION IN 2009, WE HAVE BE ABLE TO FINANCIALLY SUPPORT EVERY CLAIM, THANKS TO GENEROUS DONOR SUPPORT.

- SPECIAL FUNDRAISING REQUESTS CAN BE MADE TO THE BOARD FOR THEIR REVIEW AND APPROVAL.
- AN INJURED RACER OR HIS FAMILY HAVE 60 DAYS FROM THE TIME OF THE ACCIDENT TO MAKE A CLAIM FOR SUPPORT.
