## Carl Albert State College AA General Studies Program Review 3.7 Academic Program Review 2017

Description of the program's connection to the institutional mission and goals:

The General Studies degree is intended to prepare students for transfer to four-year institutions. Those completing the degree are prepared to meet both the General Education Goals of the college, as well as preparing for major courses in specifically tailored curriculum dependent upon students' needs and transfer-institution requirements.

Carl Albert State College strives to provide student success; the AA in General Studies allows students to pursue interests and prepare for success in a less restrictive, custom format that often meets transfer-institution needs more appropriately than specific degree plans currently available at CASC.

Analysis and Assessment (including quantitative and qualitative measures) noting key findings from internal or external reviews and including developments since the last review:

Previous program reviews were outdated as the goal of the General Studies degree has shifted to four-year institution preparation. Since the last review, the general studies degree program as grown in classroom size along with an increase in the number of majors within the general studies program. Partly, due to the changes of communications and fine arts degree falling under the umbrella of general studies.

Assessment software allows tracking student success in specific courses, most apropos the general education courses. Curriculum mapping further allows for data-driven assessment of programs and courses.

#### A. Centrality of the Program to the Institution's Mission:

The mission of Carl Albert State College is to provide affordable, accessible and exceptional education that fosters student success. The General Studies degree represents the embodiment and essence of that mission. For students both wishing to tailor their education or to explore major options, the program provides a means of guidance and structure which leads to student success.

The general studies program contributes to the institution's academic priorities in several ways. The program contributes to the college's different programs by offering optional courses that can be applied to the general education while still leaving the student with twenty-three credit of their choice. The associate of general studies will prepare students for a continuation of studies at the baccalaureate degree level at a four-year institutions. The associate degree in general studies allows the student to explore different career options through classes before finalizing a major at the four-year institution. The general studies program provides the students with a

well-rounded two-year education.

CASC faculty and staff will provide an exemplary learning community by creating excellent educational opportunities that are responsive to the needs of the area and enable students to achieve their aspirations and develop into successful participants in an ever-changing world. The General Studies degree allows the flexibility and adaptability necessary for students to succeed through responsive advising and planning.

For the formerly undecided, undeclared, or uncertain student, the General Studies program creates a flexible, yet viable means of completing a degree and transferring to a four-year institution.

**B.1**.Program Objectives and Goals:

- 1: Upon completion of the courses students will be able to critically assess and discuss competing perspectives from disciplines.
- 2: Upon completion of the courses students will demonstrate an understanding of human diversity and an awareness of global issues.

During the 2016-2017 academic year, this program surpassed the 70% threshold that is typically considered passing in letter grade assessments by meeting 88% of the targets of the course-embedded student learning outcomes (SLOs) for the required general education courses.

Although the major requirements of this degree vary based upon student and advisor consultation, the results that encompass the required 40 hours of general education demonstrate that the students are mastering the depth of general knowledge required for a degree.

Curriculum mapping assures that courses in the general education component of the degree plan meet CASC General Education Outcomes and provide a matrix for evaluation and assessment of the General Education program.

Individual program goals ensure the same quality and assessment for major-level courses which, in conglomeration, provide the major-level-equivalent component of the General Studies degree. This assessment structure ensures that students graduating from CASC with a General Studies degree receive a quality education aligned with the program goals established by the institution.

General Study Program is designed to build a student's competency in a board range of science and art courses. The students are consistently asked to think critically and communicate effectively while enhancing skills appropriate for educational and business settings.

## **B.5.** Duplication and Demand:

#### **B.5.** Duplication and Demand Issues:

#### Address Duplication:

The program is a general transfer degree.

Students may duplicate courses from other majors, combining major requirements and electives to achieve a tailored degree. A common example is Occupational Health and Safety. Prior to the creation of that degree program, a number of students pursued General Studies based on advisement from faculty and staff in accordance with degree plans from 4-year schools offering the intended degree.

#### Address Demand:

As the second-largest declared major, there is demand for the General Studies degree. However, a large portion of the numbers result from the institutional practice of placing "undeclared" or "undecided" students into the General Studies track for advisement purposes.

**B.5.a.** Detail demand from students, taking into account the profiles of applicants, enrollment, completion data, and occupational data:

A large percentage of CASC students are first-time, first-generation students. As such, many are unaware of degree requirements, major intention, or the college process. Placement in to the General Studies program allows them to be advised by faculty advisors while finding their niche and seeking academic direction. Completion data reflects the usual major-change when students declare a program-specific after one or two semesters as a General Studies major.

**B.5.b.** Detail demand for students produced by the program, taking into account employer demands, demands for skills of graduates, and job placement data:

The speech and debate (Forensics) team was revived in the Spring of 2016. That semester Carl Albert State College won three trophies at the State Tournament. Last year (2016-2017) Carl Albert State College had two different students on the team and we put on a tournament at CASC in the Fall. This year (2017-2018) Carl Albert State College has a total of four students on the team and plan to attend some tournaments in the Spring of 2018.

The Speech club is available to help students get involved with the local community at social events.

All General Education requirements are available in online format as well as traditional classes on both physical campuses. Distance delivery options further allow for student access. Online courses are held to the same student learning requirements as traditional courses and are evaluated through the Quality Matters program.

#### **B.6.** Effective Use of Resources:

Resources include financial support, (state funds, grants and contracts, private funds, student financial aid); library collections; facilities including laboratory and computer equipment; support services, appropriate use of technology in the instructional design and delivery processes, and the human resources of faculty and staff.

#### Library:

The libraries of Carl Albert State College are committed to providing access to excellent resources and services that support the teaching, learning, and research of the students and faculty of Carl Albert State College. A variety of resources are available, and input is solicited from the faculty and student body as to their needs. Library staff provides training and assistance to students in learning to access library resources through scheduled orientations, as well as individual assistance as needed.

The libraries have a total of 33 computers available for students to search the library catalog, the electronic databases, and the Internet. An audio-visual area is available in the Joe E. White Library for students to view film/DVD.

The library collections contain over 1180 titles in print and audio-visual formats pertaining to the academic discipline of English. The libraries subscribe to more than 34 electronic databases that contain thousands of full-text articles and bibliographic citations. The electronic databases include over 150 journals with full-text articles pertaining to this academic discipline, including College English, PMLA: Publications of the Modern Language Association, Assessing Writing, Journal of Technical Writing and Communication, Reading and Writing Quarterly, Writer's Chronicle, Writer, and English Journal. The databases can be accessed in each library, through any campus-networked computer, or through any computer with an Internet connection. Other electronic resources available include: Freegal Music, Freading eBooks, Films On Demand, Quick References (Web Sites), Research Help, Joe E. White Library Tour, MAGNA COMMONS: Faculty & Staff Professional Development, and Annenberg Media (videos).

Interlibrary loan is available for faculty and students when materials are needed that are not contained in the library collection.

#### Computer Labs:

There are computer labs available to students in the Joe E. White Library, the Learning Resource Center, Ollie Center and in the Holton Business Center.

## Learning Resource Center:

Our Learning resource center offers tutoring in many subjects as well as COMPASS and Placement testing.

Online tutoring is available 24 hours a day through UpSwing software; the Learning Resource Center provides face-to-face tutoring, study sessions, computer labs, and other resources.

## **Student Support Services:**

Student Support Services is a federally funded program designed to assist eligible college students, who meet income guidelines, in completing their course of study. Services include free tutorial assistance; personal, academic, and career counseling; cultural enrichment and transfer assistance to four-year colleges. Special assistance to the disabled student is also provided. The services are free to eligible students.

#### Foundation:

Scholarships are available annually for many students who require financial assistance to attend college and have demonstrated above average academic ability. Funds are provided by the Oklahoma State Regents and the CASC Development Foundation, which solicits and accepts contributions from individual and organizational donors. Most scholarships are awarded on the basis of financial need; others are awarded for academic achievement or other significant contributions to the College. A Scholarship Committee is responsible for the selection of students to receive scholarships. All funds are processed through the Business Office.
