The History and Political Science Department at Carl Albert State College understands and accepts the role that it plays in contributing to the successful implementation of the mission statement of the college. The program furthers the institution's mission by preparing students to meet the challenges of an ever evolving global culture and economy through purposeful, rigorous curriculum that reflects current trends in the field and opportunities for hands-on field experiences through volunteerism in the community.

In 2018, the department and degree changed its name from Social Science to History and Political Science. Since the last review, the History and Political Science Department has sought to increase the number of students within the department by collaborating with the Leflore County Museum, the Fort Smith Museum of History, and the US Marshall's Museum to provide opportunity for them to "experience" history. Additionally, the department sponsors a history club that provides the students with a vehicle to network with other students within the department, participate in campus activities, and attract future students for the department.

The History and Political Science Department contributes to the overall mission of the college's general education program by providing courses that are required for the completion of any degree and can be used to fulfill the elective requirements for most degrees offered by the college. The Associates of Arts Degree in History and Political transfers to four-year colleges and universities for the completion of a baccalaureate.

To fulfill the mission of the institution, the History and Political Science program is guided by the following goals:

1. Graduates will be able to identify and define the functions of the branches of the federal government



As the March 2016 issue of *Perspectives on History* reported, the number of people earning a US bachelor's degree in history dropped sharply in 2014 from a year earlier and may continue to fall over the next few years. The American Historical Association's *Perspectives on History* May 2016 issue indicated that the current decline in history majors appears to be driven by structural changes in the incredibly diverse landscape of American higher education and the national economy, local variables that reflect the consequences of actions and policies at several levels, and longer-term demographic shifts.

B.5.b. Detail demand for students produced by the program, taking into account employer demands, demands for skills of graduates, and job placement data:

The History/Political Science program provides job shadowing (as available) and guest speakers to help students with professional networking. Students are able to meet with a History/Political Science faculty member to receive help transferring to a four year University that will have a suitable transfer program, if the student plans to continue in the fields of History/Political Science.

B.5.d. Detail indirect demands in the form of faculty and student contributions to the cultural life and well-being of the community:

The History Club is available to help the local community with social events. Native American heritage is addressed in our history and political science courses. Students are volunteering at the Leflore County History Museum each semester. Students also have the opportunity to attend various events in the community related to historical content such as historical lectures, the Viking Festival, the Renaissance Festival, civil war re-enactments. Guest speakers are encouraged in the classroom as the opportunity presents. For example, the department invited and hosted a question and answer session with Congressman Markwayne Mullin. Rick West, Oklahoma House of Representatives, spoke to government classes.

The History/Political Science program is offered in traditional in class formats, interim one week formats, and online. They are offered in 8 and 16 week formats.

B.6. Effective Use of Resources:

Resources include financial support, (state funds, grants and contracts, private funds, student financial aid); library collections; facilities including laboratory and computer equipment; support services, appropriate use of technology in the instructional design and delivery processes, and the human resources of faculty and staff.

Library:

The libraries of Carl Albert State College are committed to providing access to excellent resources and services that support teaching, learning, and research of the students and faculty of Carl Albert State College. A variety of resources are available, and input is solicited from the faculty and student body as to their needs. Library staff provides training and assistance to students in learning to access library resources through scheduled orientations, as well as individual assistance as needed.

The libraries have an array of computers available for students to search the library catalog, the electronic databases, and the Internet. An audio-visual area is available in the Joe E. White Library for students to view film/DVD.

The library collections contain numerous titles in print and audio-visual formats pertaining to the academic discipline of English. The libraries subscribe to several electronic databases that contain thousands of full-text articles and bibliographic citations. The electronic databases

include over 150 journals with full-text articles pertaining to their academic discipline, including College English, PMLA: Publications of the Modern Language Association, Assessing Writing, Journal of Technical Writing and Communication, Reading and Writing Quarterly, Writer's Chronicle, Writer and English Journal. The databases can be accessed in each library, through any campus-networked computer, or through any computer with an Internet connection. Other electronic resources available include: Freegal Music, Freading eBooks, Films On Demand, Quick References (Web Sites), Research Help, Joe E. White Library Tour, MAGNA COMMONS: Faculty & Staff Professional Development, and Annenberg Media (videos).

Interlibrary loan is available for faculty and students when materials are needed that are not contained in the library collection.

Computer Labs:

There are computer labs available to students in the Joe E. White Library, the Learning Resource Center, NASNTI in the Ollie Building, and in the Holton Business Center.

Learning Resource Center:

Our Learning resource center offers tutoring in many subjects as well as placement testing.

Student Support Services:

Student Support Services is a federally funded program designed to assist eligible college students, who meet income guidelines, in completing their course of study. Services include free tutorial assistance; personal, academic, and career counseling; cultural enrichment and transfer assistance to four-year colleges. Special assistance to the disabled student is also provided. The services are free to eligible students.

Foundation:

Scholarships are available annually for many students who require financial assistance to attend college and have demonstrated above average academic ability. Funds are provided by the Oklahoma State Regents and the CASC Development Foundation, which solicits and accepts contributions from individual and organizational donors. Most scholarships are awarded on the basis of financial need; others are awarded for academic achievement or other significant contributions to the College. A Scholarship Committee is responsible for the selection of students to receive scholarships. All funds are processed through the Business Office.

The Social Sciences degree name has created some confusion among potential recruits; as such, the degree has been renamed "History and Political Science" to clarify the intent. Expectations are that students currently declared in General Studies to pursue "history" degrees will realize that there is a degree in the History field. Additionally, advising and recruiting efforts have increased. And the primary courses (HIST 1483, HIST 1493, POS 1113) are general education requirements, and other courses satisfy major requirements in Elementary Education, and potentially humanities credits. The program will evaluate declared majors over the next 2 years, and will evaluate graduates over the next 4 years. Because of the relationship of the program to general education requirement, no significant budget implications are expected.
