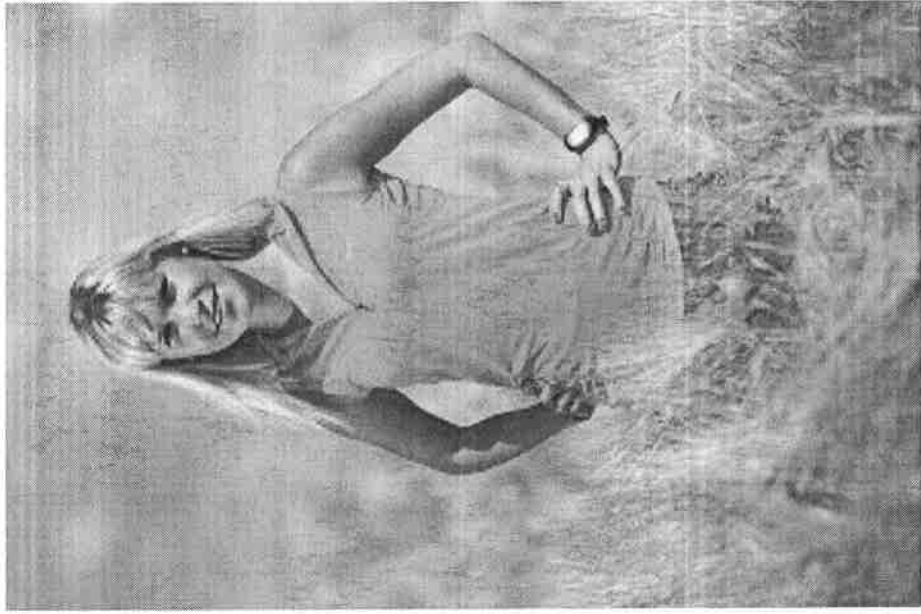

18 years old, with big dreams and high goals, Monika Korra moved from her native Norway to Dallas, TX on a track scholarship with SMU. To represent a college track team was a dream come true, and it took her a step closer towards her goal of becoming a professional runner. She felt like nothing could hold her back. Her college career started as she had hoped, with immediate success on and off the track. Then, one night during the Christmas holidays her sophomore year, she was kidnapped at gunpoint and gang raped by three men. Suddenly, her life was turned upside down, and she and others wondered if she would ever find her way back to a normal life; however, Monika was determined. In the police car on the way to the hospital that night, she made the decision to not let that event destroy or define her life - she would fight until she felt whole again. She would survive.

After assisting with the convictions of her 3 assailants, Monika bravely came forward to make her voice heard. In doing so, she turned tragedy into a message of survival and hope for anyone who has suffered through trauma or setbacks. She founded "The Monika Korra Foundation", whose mission is to create awareness of the prevalence and effects of sexual assault and to provide a place of healing for victims.

**Title IX Investigation: The Team Approach** ..... Reed A

Investigating Title IX complaints can be a daunting task and becomes convoluted when opposing interests are involved. As an investigation is conducted, relationship building with team members and the campus community is paramount, as is protecting the rights of the involved parties. We will work through two scenarios, reviewing each team member's role and approach in this process, how each team member may have different responsibilities, and how the ultimate goal is to arrive to the same outcome—finding the truth.

**Developing a Campus Building Safety Coordinator Program** ..... Maynard

Safety on campus is everyone's responsibility. At OU, a program was developed in 2016 known as the Building Safety Coordinator Program, which is designed for buildings with daily occupants, such as classrooms, offices, and residential housing. Too often, campus emergency personnel are under-trained in the critical aspects of effective emergency management programs. With the current trend toward violence on campuses, safety and security issues must include proper response by everyone involved, from students to administration. Actions need to be trained and expressed to all present on campus as options to shelter, evacuate, or respond. Proper training and planning are only as good as the exercise program that tests and evaluates them. This session will focus on creating an effective campus emergency management program and exercise plan.
