Dakota Sid comes to C'ville By Stephanie Ruff



True music fans will enjoy Sid's original thought provoking music. He will be accompanied on the mandolin and other instruments by his son Travers.

I had the pleasure of interviewing Sid last month for this upcoming show and discovered what an amazing journey his life has been. Sid was born in Southern California but his family moved to North Dakota when he was four years old. He grew up on a cattle ranch living the cowboy lifestyle. Later his family farmed in Washington State and then they returned to California when he was a sophomore in high school. His parents were very religious so his early exposure to music was gospel. He learned to play piano and later

moved on to the guitar. He spoke fondly of his first guitar-a National steel dobro style guitar that his aunt had won as a raffle prize at the Texas State Fair. It was the only instrument that was ever stolen from him.

Sid left home at 18 and headed to San Francisco amercing himself in the 60's Haight-Ashbury music scene. He played rock -n- roll but started leaning towards playing more of his "own" folk style music. Moving on to Berkeley, he acquired the name "Dakota" Sid because of his experiences in North Dakota. Life was intense and for survival reasons Sid eventually left the Berkeley music scene of the 60's. Later, Sid agreed to do the casino circuit as bills needed to be paid. It was a horrible time for Sid. For four years, under contract he worked grueling hours playing other peoples music. The casino scene nearly did him in and he came back home to California to recover. He eventually pulled himself out of a depression and started writing and playing his own music again. He moved around living in places like Nashville and Austin, Texas but always returned



Understanding the Ballot Propositions

I just spent a good part of my weekend educating myself on the five Propositions appearing on the June 2010 Ballot. I attended the May Children's Roundtable and heard: Trudy Schafer, League of Women Voters joined Rosalind Gold (Nat'l Assoc. of Latino Elected Officials), Eric McGhee (Public Policy Institute of California) and Kathy Bowler (K.Bowler Group) discuss the open Primary and Electoral reform. I watched *youtube* videos and heard bipartisan talking points explain each proposition. I also read the official voter information guide. Here is my report of what I've learned.

We have three measures brought to us by our Legislature (13,14,15) and two (15,17) from petition. They range from Auto Insurance rates to Fair Election practices. Two of these Propositions are Constitutional Amendments (13,16) therefore as such, any changes require they be brought back the voters.

Prop 13 Limits on property tax assessment/Seismic retrofits: This Constitutional Amendment simplifies existing law and asks us to decide if buildings (specifically masonry/brick) requiring earthquakes retrofits should result in higher property taxes because of the increased safety value. Current law states if these buildings are earthquake retrofitted, they are exempt from property tax re-assessment for 15 years. Prop 13 lifts that time limit. Our legislature put this on the ballot to simplify and consolidate existing language and to encourage safety. There are no arguments against it. I imagine the "property owners" in this case include commercial properties as well as private residences. So if this passes everyone gets a break for the good of public safety....

Prop 14 Primary Elections: It sounds simple enough: Allow all voters, regardless of party affiliation, to see and vote for all candidates who qualify on the Primary Ballot. As a result only the top two candidates will move to the General Election. Well, we tried this before. The earlier version was known as the Blanket Primary California 1996 Prop 198. In a Blanket Primary, voters have the ability to cross party lines to choose a candidate. (Blanket Primary was struck down by U.S. Supreme Court ruling as a violation of political party First Amendment Right of Association in 2000.) This new law, if passed, would only pertain to state legislative and congressional offices, not Presidential elections.

Currently California operates under a modified closed primary system. You may choose a Party affiliation or decline to state. Decline to state voters receive a nonpartisan ballot that contains only the candidates for nonpartisan offices and measures to be voted upon at the primary election. Candidates could choose **not** to declare their *Party* affiliation on the Primary Ballot.

As all voters know by now, sometime these measures have a deeper meaning. Proponents say this will focus voters on the issues, not the politics. After many years of dealing with broken political promises, I am leery of this as a potential outcome. Only the top two vote-getters in the Primary Election would go on to the General Election this fall. Let's dig a little deeper shall we? According to Kathy Bowler this Proposition is troubling for California and was "...put on the ballot late at night, during budget negotiations driven by the Governor, with no public hearing and no gathering of signatures...it favors incumbents and wealthy candidates". Currently the Primary Election Ballot allows voters to pick candidates based on their political party beliefs. Also voters have the freedom to write-in a candidate of choice in the General Election. This would change under Prop 14. In some elections, it may put more power in the hands of California's 20% Decline-to-State voters, as well. This measure would also raise the minimum number of registered party members required for a minor party to be recognized on the Primary Ballot. (Currently only the Green and American Independent parties would meet that obligation.) Eric McGhee who reminded advocates that the Public Policy Institute provides information and takes no positions on ballot measures. He explained their "data geek" research shows outcomes of primary elections do change because of party crossover. Cont. on page 8

Fire Chief's Report By Alan Kinne

Camptonville Fire Department has a new Assistant Chief. His name is Mark Jokerst. Some of you probably know him as the chief of the Pike City Fire Department for the last few years. Well, now he belongs to us!! He brings a great deal of experience and knowledge to our department. Mark has been coming to Camptonville for quite some time helping out with our training. At one point, he was the acting Chief of Camptonville during our transition period. I give Mark a lot of credit for turning this department around and making it what it is today.

Our Fire Department Academy has drawn to a close. May 16 was the final written exam, which consisted of 100 mostly multiple-guess questions. Our final standings should be computed soon. I really want to thank Captain Tony Scarafiotti for teaching us a lot about fire fighting. As you might recall, Tony is a career firefighter with the Grass Valley Fire Department. Our graduation ceremony is scheduled for Sunday, June 6, 2:30 PM, at the Camptonville School. A spaghetti dinner will be served after the ceremony. We would like to invite everyone to attend. Those graduating will obtain their Volunteer Firefighter I Certificate. This is not necessary to be a volunteer firefighter, so it shows the dedication that our department has. Anyone wishing to bring a side dish or dessert feel free to do so. It would be greatly appreciated. Hope to see you there.

We recently signed Mutual and Automatic Aid Agreements with North San Juan, Pike City and the Forest Service. Agreements such as these are essential to any fire department. It is good to know that help is on the way.

On June 26, Camptonville Fire will be joining North San Juan, Pike City, Downieville, Sierra City and the Forest Service for a training day at Convict Flat. Each department will be putting on a demonstration of one element of fire, rescue and EMS operations. Our department will be doing an Emergency Medical Service demo.

Once again I would like to ask all the homeowners to please put up some sort of house number sign. Every day as I listen to the radio, I can hear the frustration in the voices of the firefighters and ambulance crews as they try to find an address. That extra few minutes it takes us to find your house could mean a big difference in the outcome, especially on a medical call

There were 5 calls for the month of April: 3 medical, 1 smoke check and 1 motor vehicle accident. For May we have had 7 calls so far, 5 of them in the last 6

days, as of this writing. We have had 3 medicals, 1 public assist, 2 motor vehicle accidents, and 1 vegetation fire. The number of volunteers responding on any particular day is averaging about 7. At one call in May, we had 11. Good response from a good group.

Rafting season is open, so be on the alert for rafters and kayakers. Use caution at all times. Enjoy a beautiful spring.

Bullards Bar and all campgrounds on Highway 49, up to and including Wild Plum are open. Sardine and Salmon Creek open by Memorial Day. Gold Lake road is only open about 3 miles. Packer Lake road is open to Packer Lake only. Sardine Road is open to Sardine Resort. There is still ice on Sardine Lake. Brandy City Pond area is open. Sand Pond is open (with some snow). The 25 Road (Cal-Ida) is open for about 8 miles. The 35 Road is open about 6 miles.

Trails in the lower elevation are open: Bullards trails, Fiddle Creek Ridge, Halls Ranch. The North Yuba Trail is especially nice this time of year. Sierra Buttes Trail, the PCT and other high country trails are closed with snow. There should be something for everyone.

Rainfall for May 2010 is 1.69 inches, bringing our season total to 50.83 inches. Last years total was 48.41 inches. Please use caution as things begin to dry out.



But did the *Blanket Primary* increase bi- partisanship? McGhee stated "Not really. There was not an increase of bi-partisanship in the behavior of the people elected."

It is also important to note how Prop 14 will relate to the redistricting of California and The Voters First Act. which passed November 2008. Every ten years. following the federal Census, political district lines are redrawn to ensure that politicians serving on the same governing body (such as Congress, state legislature, board of supervisors, etc) represent approximately the same number of people. This is done to provide voters equal representation. If Prop 14 passed, in heavily partisan districts, it is possible the top two vote- getters could be from the same party. This could result in less, not greater choice. The Center for Governmental Studies in Los Angeles has issued this report finding that more than one-third of all state and congressional races could produce general elections between members of the same party. www.ca.lwv.org/lwvc/issues/redistricting.html **Prop 15** Fair Elections: This is a pilot program concerning only the office of the Secretary of State in the 2014 and 2018 elections. This office was chosen because it is the office that regulates elections. Prop 15 would change California law to allow public funding of campaign financing for the election of the Secretary of State. It would also set up a public finance program and is expected to raise about \$6 million every four years. To qualify candidates must adhere to strict spending limits and forgo private financing, including their own. Eligibility would require thousands of \$5.00 contributions and 75,000 signatures as well. The measure would also raise money for public funding of the political campaigns of candidates by increasing lobbyist fees from \$12.50 a year to \$350.00. Additionally it gives the Legislature the power to expand or extend this program to other public offices. It should be noted though; if both Propositions 14 and 15 pass we would have conflicting funding formulas. The formulas for candidates to receive funds are based on the present closed primary system. If Prop 14 passed candidates who are not affiliated with any major party, could not receive public funding for the primary election. They would only be able to receive funding in the general election. You can see the conflict; with passage of Prop 14 it would be unlikely they would make it to the general election.

Prop 16 Local Public Electricity: This Constitutional

Amendment would require 2/3's of California's voters to agree before local governments could use public funds (including tax revenues, rate payer funds, revenue from bonds etc.) to start up or implement a Community Choice Aggregation (CCA). Okay stay with me this gets a little confusing: Currently local jurisdictions receive electricity in one of four ways:

- Investor Owned Utility (IOU) such as PG&E
- Public Owned Utility (POU) such as SMUD
- Electric Service Providers (ESP) offer electricity to customers who have chosen not to receive electricity from the IOU or POU that normally serves their area. ESP uses the local utility transmission lines and distribution system.
- CCA a city or county (or combination), who also provides electricity to a local community through a contract with an ESP. In addition customers in the service area would automatically receive electricity from the CCA unless they elected to do otherwise. Only one CCA currently exist in our state.

As more California communities explore the use of "greener" power, the number of CCA's is expected to expand. Proposition 16 law would require a 2/3's voter approval for CCA development. Currently these specific local government actions are normally accomplished without such votes.

PG&E has contributed \$28.5 million to Yes on 16 campaign so far....

Prop17 Auto Insurance: Current law (Prop 103 1988) requires individuals who operate a car to have specific liability insurance. The rates for this insurance are based on driving record, number of miles driven and driver experience in that order. Current law under Prop 103 does not allow insurance companies to use continued coverage to determine eligibility or premium price. Prop 17 would change current law to allow continued coverage to become a factor. This may harm individuals who had a gap in coverage of 90 days or more because of inability to pay.



Well, what a wet spring and a slow start to the summer gardening season. Who ever would have thought that nothing would be in the ground until after June 1st this year? Mother Nature has her reasons and ways she likes to get things done and hey-we need the water!

Now it is time to get busy and catch up. First get those veggie gardens in and maybe plant more starts than seeds this year so you get quicker results.
