Basic Benefits:

Medical Expenses - Part B coinsurance (generally 20% of Medicare-approved expenses) or co-payments for hospital outpatient services. Plans K, L and N require insureds to pay a portion of the part B coinsurance or co-payments;

Blood - First three pints of blood each year;

Hospice - Part A coinsurance.

We, Individual Assurance Company, Life, Health & Accident, can only raise your premium if we raise the premium for all policies like yours in this State. We will not change the premiums for this policy during your first year of coverage. Thereafter your premium will increase each year based on your age at that time. No rate adjustment may be made on an individual basis. Also, your renewal premiums may change on a renewal date following the Effective Date of any change in the deductible and/or coinsurance amounts which you are required to pay under Medicare. Any such premium change will be based on the actuarial computations that we then use to determine the renewal premium.

This Outline of Coverage does not give all the details of Medicare coverage. Contact your local Social Security Office or consult "The Medicare Handbook" for more details.

EXCLUSIONS

We will not pay benefits for: (a) Expenses incurred while coverage is not in force except as provided in the Extension of Benefits section; (b) That portion of any expense incurred which is paid for by Medicare; (c) Services for non-Medicare Eligible Expenses unless specifically covered under this policy, including, but not limited to, routine exams, take-home drugs and eye refractions; (d) Services for which a charge is not normally made in the absence of insurance; or (e) Loss or expense that is payable under any other Medicare Supplement insurance policy or certificate.

REFUND OF PREMIUMS

The policy contains refund of premium provisions which provide for the partial refund of premium following your death or your cancellation (surrender) of the policy.

COMPLETE ANSWERS ARE VERY IMPORTANT

When you fill out the application for the new policy, be sure to answer truthfully and completely all questions about your medical and health history. The company may cancel your policy and refuse to pay any claims if you leave out or falsify important medical information.

Review the application carefully before you sign it. Be certain that all information has been properly recorded.
