Outline of Medicare Supplement Coverage - Benefit Plans A, F, G, and N

This chart shows the benefits included in each of the standard Medicare supplement plans. Every company must make Plan A available. Some plans may not be available in Your state.

BASIC BENEFITS:

- **Hospitalization:** Part A coinsurance plus coverage for 365 additional days after Medicare benefits end.
- **Medical Expenses:** Part B coinsurance (generally 20% of Medicare-approved Expenses) or copayments for hospital outpatient services. Plans K, L, and N require Insureds to pay a portion of Part B coinsurance or copayments.
- **Blood:** First three pints of blood each year.
- **Hospice:** Part A coinsurance.

*Plan F also has an option called a high-deductible Plan F. This high-deductible Plan pays the same benefits as Plan F after one has paid a calendar year \$2,240 deductible. Benefits from high-deductible Plan F will not begin until out-of-pocket expenses exceed \$2,240. Out-of-pocket expenses for this deductible are expenses that would ordinarily be paid by the policy. These expenses include the Medicare Deductibles for Part A and Part B, but do not include the Plan's separate Foreign Travel Emergency Deductible.

If You find that You are not satisfied with Your policy, You may return it to Loyal American Life Insurance Company, P. O. Box 26580, Austin, TX 78755-0580. If You send the policy back to Us within thirty (30) days after You receive it, We will treat the policy as if it had never been issued and return all of Your premiums.

POLICY REPLACEMENT

If You are replacing another health insurance policy, do NOT cancel it until You have actually received Your new policy and are sure You want to keep it.

NOTICE

RENEWABILITY

This policy is guaranteed renewable for life.

SPOUSAL DISCOUNT

"Spousal Discount" is a discount that is available when the applicant's spouse or state-registered domestic partner living within the same household enrolls or is enrolled in a Medicare Supplement policy provided by or through Loyal American Life Insurance Company. Household is defined as a condominium unit, a single family home, or an apartment unit within an apartment complex. Assisted Living Facilities, Group Homes, Adult Day Care facilities, and Nursing Homes or any other health residential facility are not included in the definition of Household.

The spousal premium discount will be removed if the other Medicare Supplement policyholder whose policy status entitles the Loyal American Life Insurance Company policyholder to the discount no longer resides with the Loyal American Life Insurance Company insured, no longer has a Medicare Supplement policy through Loyal American Life Insurance Company, or due to divorce or termination of domestic partnership. The addition or removal of the discount will occur on the billing cycle following the date the Company learns of the change in eligibility.
