Shree Lohana Mahaparishad – Education Aid Policy 2025–26

Objective

To empower students of the Lohana community through need-based and merit-based financial assistance in the form of scholarships and interest-free education loans, fostering access to quality education across levels and disciplines.

Eligibility Criteria

1. The applicant must belong to the Lohana community.
2. The annual family income should not exceed ₹6,00,000.
3. All applications must be submitted online only through the official LMP portal. No physical applications will be accepted.

Category-wise Support

Education Level	Annual Fee Limit	Family Income per Annum	Aid Type & Amount
Class 5 to 12, 10+Diploma	Up to ₹30,000	4 Lacs per Annum	Scholarship of up to ₹5,000
Undergraduate (UG / PG) courses	Up to ₹30,000	4 Lacs per Annum	Scholarship of up to ₹5,000. Loan option for higher amount
UG courses with fees above ₹30,000	> ₹30,000	6 Lacs per Annum	Interest-free education loan only
Medical (UG /PG) (MBBS/MD/MS)	Up to ₹25,00,000	6 Lacs per Annum	Loan up to ₹3,00,000 or 50% of tuition fees, whichever is lower
Other professional/higher education (Eng, PG)	Up to ₹6,00,000	6 Lacs per Annum	Loan up to ₹2,00,000 or 50% of tuition fees, whichever is lower

Loan Terms

- Repayment begins six months after course completion.
- To be repaid in 24 /36 equal monthly instalments.
- A Lohana community guarantor is required.
- Students must declare:
 - Any existing or previous loans from LMP.
 - Any other financial aid/scholarships received.

Ineligible Courses

- Online or distance learning programmes
- Foreign education courses
- Private coaching or certificate programmes not affiliated with recognized universities

Scholarship Disbursement

- Scholarship for School Student amount will be paid to the student via cheque (post Mahajan contribution).
- Local Mahajan must contribute 30% of the sanctioned amount for the scholarship to be disbursed.
- Education loans will be paid directly to the institution via cheque.

New Strategic Initiatives (2025–26 Updates)

- **Higher Loan Limit for Medical Courses**
Loan limits for MBBS students may be increased due to rising fees (up to ₹25 lakhs), based on merit and financial need.
- **Revised Income Limit for Scholarships**
Income limit increased to ₹4 lakhs per year for school and higher education scholarships.
- **Revised Income Limit for Education Loans**
Income limit increased to ₹6 lakhs per year for professional and vocational course loans.

Approval Process

- Application must be approved and signed by:
 - Local Mahajan
 - Zonal/Regional Committee Member

- 33.33% at Mumbai, 40% across India for economically weak LMP students
- 20% across India, for all referred LMP students

All students must be referred through LMP's internal selection process.

3. Laduma Dhamecha – Yuva Unstoppable Scholarship

In collaboration with Yuva Unstoppable, this scheme supports science stream and CA students from economically weaker sections.

Science Stream Scholarship:

- ₹50,000 per year for Class 11–12 (or full Byju's Akash coaching fee)
- ₹25,000 per year for graduation (max ₹1,00,000 for 4 years)

CA Coaching Scholarship:

- ₹50,000 for CA Intermediate
- ₹50,000 for CA Final (after clearing Intermediate)

Criteria:

- Minimum 75% in SSC (Science) / HSC / 240 and More Marks in CA Foundation
- Family income ≤ ₹3,00,000
- Aptitude test + Interview + Home visit

Coaching fee is paid directly to the institute
