

"Win 1 of 5 Hisense TVs" Prize Draw Terms

All prize draw entrants will be deemed to have accepted these terms and conditions and deemed to have agreed to be bound by them when entering this prize draw.

- 1. The promoter of this prize draw is Affordable Mobiles Limited trading as Affordable Mobiles, 5a The Parklands, Lostock, Bolton, BL6 4SD ("Promoter/AO/us/our/we").
- 2. All customers who have received a promotional email from AO are eligible for a single entry into the prize draw. Entry shall be via the entry mechanism shown in the promotional email.
- 3. Each person who purchases a new contract from the <u>www.affordablemobiles.co.uk</u> website during 00:00 10th June 2024 23:59 on 23rd June 2024 will automatically be entered into the prize draw.
- 4. For these purposes, a purchase requires all the following steps to be completed: [a] the individual has passed the network credit check for a new contract (not an upgrade); [b] handset is delivered and connected to the network; [c] handset not returned within 14-day statutory cooling-off period; [d] customer has paid in full all of their first 3 monthly bills to the network operator.
- 5. 5 winners will be chosen to win 1 prize each. Each prize is one Hisense TV, model 55U7KQTUK.
- 6. Prize draw details, including details of method(s) of entry, published on Our website(s), shown in promotional emails sent by AO and/or shown on AO's official social media pages, form part of these terms and conditions.
- 7. The prize draw is open for entry until 23rd June 2024 23:59, after which time the winner will be randomly selected.
- 8. All prize draw entrants must be aged 18 or over.
- 9. Entry is open to residents of the UK excluding Channel Islands or the Isle of Man, except employees (and their families) of AO, the suppliers of the prize(s) and any other companies associated with either AO or the prize draw. Please note that, whilst AO offers home delivery to UK postcodes (excluding the Scottish Highlands, Scottish Islands, Channel Islands, the Isle of Man or the Republic of Ireland) certain products cannot be delivered to certain parts of Northern Ireland. - 14. A winner will forfeit their prize if the network operator confirms that they have not paid one or more of their first three monthly bills in satisfaction of condition 3[d] above. Under these circumstances the prize will be awarded to a substitute winner, which shall be the next entry selected at random.
