Century City Bus Shelter Advertising Terms and Conditions

1. The contract period runs on a calendar month basis from the 1st day of the month.
2. The minimum contract period is 3 months.
3. The artwork Installation date is the 1st of every month. Should the 1st fall on a weekend or public holiday, the installation will take place the following working day.
4. The client is solely responsible for the development of artwork and for it to be emailed to info@centurycity.co.za timeously for approval.
5. All artwork needs to be approved by the Century City Property Owners' Association (CCPOA) the CCPOA reserves the right to refuse any artwork at its own discretion.
6. The CCPOA shall have full and exclusive control over the installation, change and removal of applied artwork.
7. Should the artwork become damaged or vandalised, the CCPOA will be responsible for replacement of artwork.
8. In order to guarantee a full showing, artwork must be received at least 5 working days before the installation date. If the artwork is submitted late, the material is not guaranteed to be installed on time and the advertiser is not assured of a complete showing. No refunds are payable.
9. A full calendar month written notice needs to be given for cancellation of a contract.
10. Printing and Installation will only take place once payment for the first month has been received. For the subsequent months of the contract, payment must be received by the 1st of the month.
11. Reservation of bus shelters can only be made on receipt of a signed contract.
12. In the event of the client wishing to change their artwork during the term period, this will be at an additional cost to the client.
