Implementation update on the CGIAR System 2019-2021 Business Plan

<u>Purpose</u>: This document sets out a proposed approach to regular tracking against the 10 actions as set out in the CGIAR System 2019-2021 Business Plan, building on the responsibility and monitoring framework for implementation (set out in Section 3, part I of the Business Plan).

Action Requested: The System Council is requested to take note of implementation progress on the 2019-201 Business Plan and:

- i. Provide strategic input on possible areas for priority focus;
- ii. Provide input on whether a proposed 'dashboard' approach would optimally meet ongoing tracking needs.

The 2019-2021 Business Plan: Ensuring effective implementation

Upon approval, at the System Council's 7th meeting in Seattle in November 2018, the <u>System Council requested</u> that *a report against progress markers on all 10 actions in the 2019-2021 Business Plan be provided annually as a means of understanding progress and identifying any areas where implementation support that may be required.*

The <u>slides that follow</u> set out an overview of the 10 actions and the headline status of each with reference to actions anticipated for 2019.

For future updates, it is proposed to develop this further into a **simple online dashboard** that would allow the user to see this information in one place at any time.
