Funding Standing Panel on Impact Assessment (SPIA)

Purpose

This document sets out a recommended mechanism to facilitate the provision of funding to support SPIA-related activities through Window 2 of the CGIAR Trust Fund.

Following the System Council's agreement at its 7th meeting that SIMEC would work with the System Management Office on the means of funding of the approved SPIA budget, the System Management Board ('SMB') considered, at their 13th meeting on 2-3 April 2019, a range of possible options for the funding of SPIA activities for the 2019-2021 period.

The Board endorsed the option of establishing a module of the CGIAR Platform for Big Data in Agriculture, the background to and rationale for which is set out in this document (noting that it is the role of the SMB, under Charter of the CGIAR System Organization to "recommend proposals and indicative funding requirements for the CGIAR Portfolio").

Action Requested

The System Council is requested to review, and if thought appropriate <u>approve</u> the mechanism set out in this document such that the program activities of SPIA are classified as a new module, 'Improving and institutionalizing collection of data', to be administratively assigned to the CGIAR Platform for Big Data in Agriculture.

Context

1. Based on detailed documentation presented at the System Council's 7th meeting, the System Council approved the workplan and budget for CGIAR's Standing Panel on Impact Assessment ('SPIA') pursuant to decision SC/M7/DP7 as reproduced below – with emphasis added relevant to the SPIA budget.

SC/M7/DP7: 2019-2021 Advisory Bodies Work Plans and Budgets

The System Council, pursuant to article 6.1(u) of the CGIAR System Framework:

- i. Agreed that for 2019 a certain degree of flexibility is needed for the operations of the Advisory Services and the Shared Secretariat and <u>that workplans and</u> <u>budgets for 2020 and 2021 will be re-assessed in 2019 by the System Council</u> <u>supported by SIMEC.</u>
- ii. Endorsed the workplan of the ISDC for 2019, and asks the ISDC to largely focus on foresight activities and developing a protocol on horizon scanning;
- iii. Endorsed the workplan and high budget scenario of SPIA¹, with the understanding that SIMEC will work with the Assurance Oversight Committee for a value-for-money review of the budget; and SIMEC will work with the System Management Office on the means of funding of the budget, with that proposal to be presented by not later than 3 December 2018 for approval by the System Council by electronic means;
- iv. Requested further refinement of the workplan and budget of the evaluations work stream of the Shared Secretariat, with an updated workplan to be developed that takes into account the feedback provided during the System Council meeting session; and
- v. Endorsed the budget envelope for staffing of the Advisory Services Shared Secretariat based on 3-year employment contracts for staff.
- 2. The requested 'value for money' review (sub-point iii of the System Council's decision) was undertaken to the satisfaction of SIMEC by the System Council's Assurance Oversight Committee by mid-December 2018 with support of the CGIAR System's Internal Audit Function. The budget ceiling for SPIA did not alter as a result of that exercise, but additional narrative material was provided for the workplan.
- 3. During the final day of the SC7 meeting, one of CGIAR's key Funders confirmed that they would wish to contribute towards funding SPIA but would only be able to provide that funding through Window 2 of the CGIAR Trust Fund. Discussions continued with this Funder since early December 2018, with it being reiterated that their funding for CGIAR can only be provided via Window 2, and of their projected CGIAR financing contribution, they wish US\$ 1.3 million in funds to be provided to SPIA in 2019.

SPIA 2019-2021 approved budget ceiling by program activities

4. The SPIA budget ceiling approved by the System Council for the <u>2019-2021</u> period is set out below (and objective 3 funding needs for 2019 is highlighted). The table also shows the projected funding for the 2022-2024 years, noting the longer-run nature of impact assessment work.

Funding avenues: Provisions and historical approach to SPIA budget support

- 5. Pursuant to the legal agreements approved by CGIAR's Funders and Centers on 17 February 2017 (Decision reference: SC/M3/EDP4) Window 2 funds can only be utilized for CGIAR research programs or platforms, and not 'System Entity' financing. Under the CGIAR Policy on CGIAR System Cost Financing' System Entity financing is provided through Window 1 of the CGIAR Trust Fund, based on a cost-sharing percentage that is collected on Window 2 and Window 3 Funder contributions to the CGIAR System.
- 6. Prior to the new multi-year budget proposal approach (2019-2021) funding of System entities, SPIA financing was provided through two past sources:
 - a. A 'Window 1' special initiative concept approved by the former CGIAR Fund Council, and financed through the 'Strengthening Impact Assessment in CGIAR" grant proposal³, which largely contributed to financing impact assessment efforts under 4 key workstreams; and
 - b. Additional funding from the approved budget of the former 'Independent Science for Development Council', which largely contributed to the financing of honorarium and other costs for the external independent SPIA members themselves (SPIA then being a sub-group of the ISPC).
