

Request for Proposals: Data Management Maturity Assessment

What we are seeking:

The CGIAR System Internal Audit Function (IAF) is seeking to engage an experienced Data Management consultant to carry out an assurance engagement to evaluate the Data Management Maturity within CGIAR.

Background

Data Management within CGIAR is largely segregated where each CGIAR entity (i.e. CGIAR Centers and the CGIAR System Organization in this document) is responsible for acquiring, validating, storing, protecting, and processing required data to ensure its accessibility, reliability, and timeliness for the users.

CGIAR entities have implemented a suit of business applications used to perform various business functions including enterprise resource planning (ERP) systems, human resource management and recruitment systems, and risk management systems to name a few. CGIAR entities use various document repository platforms including SharePoint, EPrints3, Dropbox and OneDrive.

CGIAR entities mainly use in-application reporting and excel to meet reporting requirements. The Business Intelligence and data visualization tools in use are Tableau, Snowflake, Power BI, QuickSight and, Qlik Sense.

The CGIAR System Internal Audit Function (IAF) has actively participated in development of Research Data Management good practice note (GPN) that could be used to assess research data management maturity.

State of Research Data Management at CGIAR

At CGIAR level, the expectations on research data management have been established through the formal approval of the CGIAR Open Access and Data Management Policy (CGIAR OA/DM) on 02 October 2013.

Implementation of and compliance with this policy by the CGIAR System office, its members and their partners within the compliance with this policy by CGIAR entities would be phased over the transition period from the effective date of the policy for an initial period of five years, with comprehensive implementation by the end of 2018. The policy is to be utilized in conjunction with the CGIAR Open Access and Data Management Implementation Guidelines.

Request for Proposal CGIAR System Organization, issued: 09 March 2020

The implementation of the CGIAR OA/DM policy is currently incorporated in the "Organize" module of **Big Data platform** which aims to "harness the capabilities of Big Data to accelerate and enhance the impact of international agricultural research".

Within the context of the imminent institutional changes in CGIAR, the CGIAR System IAF is seeking to engage an experienced Data Management consultant to carry out an assurance engagement to evaluate the Data Management Maturity within CGIAR.

In 2020 CGIAR System IAF will also perform a cyber security assurance engagement. This will encompass evaluation of the CGIAR cyber security management capabilities to mitigate against cyber security risk and vulnerabilities including network security, application security, endpoint security, data security, data center security, database security and end-user education. The synergy between the cyber security and the data management maturity assessment will be highly desirable.

In addition, the consultant will be required to propose improvements of management of data assets that would benefit all entities within CGIAR in the context of the organizational change.

Deliverables and timeline:

The scope of this engagement includes all CGIAR entity data management arrangements. The review should consider any data management reviews carried out at a Center level in the last two years. The consultant needs to use one of the recognized data management maturity assessment frameworks.

At different stages of the engagement there will be validation of results by the CGIAR System IAF to ensure engagement deliverables are on track and in line with intended objectives.

The engagement's output will be a report presenting a combined picture of the level of data management maturity across CGIAR, discussed and shared with all CGIAR Center data management focal points, Center AC Chairs, Center Heads of Internal Audit and SMB's Audit and Risk Committee.

Knowledge, skills, and abilities:

The applicants must demonstrate prior experience and technical knowledge of conducting similar reviews within a context of a complex international organization with distributed structures.

Evaluation Criteria:

All proposals will be evaluated on a two-step basis with the technical proposals and the financial proposals being evaluated separately to determine the best value for money. Bidders whose proposals are short-listed may be contacted with questions for clarification.

The evaluation criteria will be as follows:

i) Technical Proposal 80% and includes:

 Quality and completeness of the quote response 	10%
 Quality of the proposed service 	30%
 Strategic, functional, and technical fit 	10%
 Experience with similar engagements 	20%

How to submit a proposal:

Please submit a narrative proposal and a budget proposal as two separate documents to smo-procurement@cgiar.org. Both documents can be attached to the same email.

Narrative proposal will consist of no more than 10 pages using Microsoft Word or similar format, font size 11pt., margins no smaller than one inch.

Budget proposal will be presented using Microsoft Excel or similar format and consist of, at a minimum, the following line items: consultant time, resources, travel. The budget will be presented in US dollars.

<u>All proposals must be received no later than April 14 2020.</u> Only electronically submitted proposals will be considered. Late proposals will not be considered. Shortlisted bidders will be contacted no later than April 24 2020.
