This is a bi-weekly newsletter on the transition to One CGIAR from the co-chairs of the Transition Consultation Forum (TCF). <u>One CGIAR</u> refers to a future, more unified and integrated CGIAR, initially set out in the System Council-endorsed recommendations of the System Reference Group.

MESSAGE FROM THE CO-CHAIRS OF THE TRANSITION CONSULTATION FORUM (TCF)

Dear CGIAR colleagues and stakeholders,

We hope this message finds you safe and well as we all grapple with the impacts and new operational reality of the Covid-19 pandemic.

We commend the efforts made by Center/Alliance colleagues, the System Organization, Funders, and partners to share information and coordinate response measures at this critical time. Right now we must do all we can to protect the health and safety of our staff and stakeholders. As we do so, we need to look ahead and seek ways to safeguard the continuity of our operations and collective capabilities. An effective response requires that we come together in solidarity, and that we collaborate across countries, institutions, and disciplines.

This crisis also highlights some of the tangible reasons for which we need One CGIAR: more integrated AR4D to advance 'One Health' and address some of the root causes of global pandemics; common policies, services, and systems to support rapid, coordinated responses to global events; and more pooled funding to facilitate coordinated Funder engagement and risk sharing.

At our 17 March call with the TCF, as well as in subsequent Transition Advisory Group (TAG) discussions, we have collectively begun to assess the implications of Covid-19 for the transition to One CGIAR. As TCF Co-Chairs, we remain committed and engaged in the transition agenda – ensuring that we do this in a highly adaptive way. This means operating via a continuous assessment of risks and opportunities, and being ready to quickly implement course corrections when necessary. We are mindful of the demands that this transition places on staff time and other resources. In transition areas that require deeper integration across CGIAR, and more significant contributions from staff, such as policies and services, most work can wait until a unified governance structure and the One CGIAR Executive Management Team ('EMT') have been established later this year. Accordingly, TAG4 on policies and services remains on hold for the time being.

At the same time, in priority areas for 2020 – including unified governance, the EMT, and a 2030 Research Strategy – work can continue for now and remains on track to the timelines we collectively adopted in February.

Against this complex backdrop, this third edition of our newsletter provides an update on the independent legal opinion on delivering unified governance under One CGIAR; practical steps underway to enhance communication and stakeholder engagement; the code of conduct for the transition, now operational after welcomed inputs since our past call; and an overview of ways to become involved for those that are able to do so. You will also find an up-to-date list of TAG members and a calendar of recent and upcoming meetings and events.

This newsletter goes directly to all TCF and TAG members, CGIAR communities of practice, as well as TAG co-stewards and support staff, and it has been posted on the <u>CGIAR website</u>. EXTERNAL LEGAL OPINION ON DELIVERING UNIFIED GOVERNANCE UNDER ONE CGIAR: AN UPDATE

Aware of the importance of CGIAR's governance structure operating according to best practice and in line with international standards, at its 16th meeting, the System Management Board ('SMB') endorsed a stepwise approach to the establishment of the One CGIAR Common Board by 1 October 2020, in a way that maintains appropriate pace in decision making by the General Assembly of the Centers, the SMB and Center/Alliance Boards alike.

To provide the requisite assurance to Center/Alliance Board members, our Funders, and our headquarter and other hostcountry partners, that a One CGIAR Common Board is legally possible and meets best practice governance standards for international organizations, the SMB commissioned at that same meeting, the provision of an external independent legal opinion on key questions arising under One CGIAR, including:

- Whether there is a defined governance code or defined laws or regulations that are legally binding on International Organizations (that have privileges and immunities)?
- Are there any legal requirements on the part of the System Organization or a Center to abide by any specific national governance code or legislation regarding the role of the Board of Trustees/ Governing Board?
- For each Center/ Alliance, based on the Center/ Alliance's own governing instruments, assess whether its Board has the authority to delegate its oversight responsibilities on performance management of the Center's Director General to an empowered executive management team ("EMT") as contemplated in the One CGIAR model.
- Are there any legal concerns, including in relation to notions of organizational independence and autonomy, with the same group of people who are the voting members of the System Management Board also populating, as a 2/3rd voting majority, all of the Boards of CGIAR Centers/ Alliances (with all legal entities having international organization legal status (with privileges and immunities in the jurisdictions of their operations), and which collaborate in different ways, and will increasingly operate on the basis of common policies and business processes and practices)?
- Specifically, would each Center/ Alliance Board constituted as described in the One CGIAR approach be able to effectively carry out its statutory duties under the Center/ Alliance's own governance documents? If there are issues, how could those be effectively mitigated through appropriate governance arrangements (whether committee structures, conflicts of interest provisions, or other relevant approach)?

Through a global tender process overseen by a member of the SMB, CGIAR selected Lalive Law, a Swiss-based law firm to deliver a comprehensive legal opinion on these complex questions. The routing of that work is via the TCF's TAG3, with the final opinion expected to be delivered by 5 April 2020.

Recognizing the value of timely information on the progress of that legal opinion being shared across CGIAR as and when available, Lalive Law shared late on 27 March 2020 their *Initial Summary Findings on the Legal Opinion on Delivering Unified Governance under One CGIAR* (shared with members of the TCF and TAGs via MS Teams). As clearly signaled in the title of that work – this is an initial set of head-line findings based on their ongoing review of the various governing instruments – including detailed statutes, charters, constitutions, rules of procedures, headquarters agreements, side letters and government gazettes.

The work is ongoing – with deep appreciation to especially the Center/ Alliance Board Secretaries group for their guidance and support to ensuring that Lalive has all current governing instruments, and where there are questions that arise on these instruments, guidance and inputs have been quickly provided through both CGIAR's talented pool of internal lawyers, or via Center/ Alliance own external legal counsel.

As we await the full opinion – should colleagues have queries on the Initial Summary Findings, please do communicate those to us through <u>TCF-Support@cgiar.org</u> for on-forwarding to Lalive and discussion also in TAG3.

COMMUNICATIONS AND STAKEHOLDER ENGAGEMENT IN THE TRANSITION TO ONE CGIAR

Clear communication, co-creation, and collaboration have been identified as core principles of the transition to One CGIAR. With input from TAG1, the table below captures an initial set of near-term priorities for communication and stakeholder engagement to guide implementation over the coming months. The Transition Program Management Unit ('TPMU') – expected to be operational this May – will be tasked with developing a comprehensive communication strategy and stakeholder engagement plan for the transition process through end-2021. CODE OF CONDUCT FOR THE TRANSITION TO ONE CGIAR

Following the 17 March TCF call and an opportunity for written input, the following code of conduct was retained to guide TCF and TAG members' engagement in the transition to One CGIAR:

In our capacity as members of the CGIAR Transition Consultation Forum (TCF) and Transition Advisory Groups (TAGs), we will:

- Act with honesty, integrity, openness, transparency and commitment in the furtherance of One CGIAR
- Treat each other with dignity and respect
- Collaborate with each other across institutional boundaries
- Promote evidence-based decision making, while acknowledging and accepting there are legitimate differences of values, perspectives, and experiences
- Act with urgency and support conclusions and decisions that have been reached through meaningful, inclusive consultations
- Share information with each other, and unless otherwise agreed with other stakeholders within our respective networks, constituencies, and organizations, acting as spokespersons of the transition to One CGIAR

TRANSITION ADVISORY GROUPS

GETTING INVOLVED

For CGIAR staff and stakeholders who wish to get involved in or be better informed of the transition to One CGIAR, relevant avenues are set out below. This section will be updated with each edition of the Newsletter series.

Transition Consultation Forum (TCF)	The TCF is a high-level consultation mechanism for the transition. It includes members of the former System Reference Group (SRG), as well as all other Center Board Chairs and Directors General, all other interested voting members of the System Council, and the ISDC Chair. Membership in the TCF remains open to System Council members who have not yet joined. TCF members are invited to join a TAG and provide input on the advice prepared by other TAGs. Stakeholders, in their capacity as TCF members, are consulted and informed , but not responsible or accountable for delivering the transition to One CGIAR.
Transition Advisory Groups (TAG)	TAGs are multi-stakeholder advisory groups applying the principles of System-wide collaboration and co-creation. TAGs provide input and advice in support of relevant decision-making entities, including the SMB, the System Council, the General Assembly of the Centers, and Center Boards. TAGs remain open to any current and future members of the TCF that have not yet expressed an interest in joining a TAG, as well as other stakeholders that are not CGIAR staff and could bring a relevant contribution to the work of the TAG. TAGs decide on their own membership, in accordance with guidance from the TCF co-chairs. Stakeholders, in their capacity as TAG members, are consulted and informed , but not responsible or accountable for delivering the transition to One CGIAR.
CGIAR Communities of Practice (CoP)	TAGs have been encouraged to engage with the CGIAR CoP(s) that can provide relevant input and expertise and act as CGIAR-wide ideas networks and feedback loops. Some TAGs have extended a standing invitation to the conveners of relevant CoPs to participate in their meetings as guests. The invited conveners and/or TAG co-stewards will ensure that CoP members are informed of the work of the TAGs and have opportunities to provide input on and contribute towards relevant work products. CGIAR staff, in their capacity as CoP members, are consulted and informed , but not responsible or accountable for delivering the transition to One CGIAR.
TAG support teams	The work of the TAGs is supported by cross-System support teams, led by co-stewards. The support teams are currently made up of their co-stewards and a small number of System Organization staff and consultants. The co-stewards will be responsible for identifying and filling any capacity gaps, either through consultants or by drawing on additional Center/ System Organization staff time (typically 25—50% of their time, from a few months up to a year), compensated through dedicated transition funds. Where Center staff are sought to join a support team, co-stewards will circulate an open call for nominations to Center DGs as the decision-makers on staff deployment. Support team members retain their existing reporting lines, but will be responsible for delivery in line with TAG guidance and coordinated by the Transition Program Management Unit (TPMU).
Other means of engagement	We will keep stakeholders up to date about transition progress through regular newsletters, the TCF web page, and other channels under development (e.g. a One CGIAR webinar series, Senior Manager information kits, up-to-date FAQ), with associated feedback mechanisms. TAGs, with their support teams, will identify and communicate additional ways to engage with stakeholders.

BACKGROUND: WHAT IS ONE CGIAR?

One CGIAR is a dynamic reformulation of CGIAR's partnerships, knowledge, assets, and global presence, aiming for greater integration in the face of the interdependent challenges facing today's world. One CGIAR comprises (i) a sharper mission statement and impact focus to 2030, aligned with the Sustainable Development Goals; (ii) unified governance under a 'One CGIAR Common Board'; (iii) institutional integration, including stronger management, common policies and services, and a unified country presence; (iv) a new research modality; as well as (v) more, and pooled, funding.
