

## Chair's Summary<sup>1</sup> 13<sup>th</sup> System Council meeting Virtual meeting, 9-10 June 2021

Dear System Council Members, Active Observers, and invited guests,

With appreciation for depth and quality of conversations that remain possible through global conferencing platforms – our third virtual meeting was held in the context of the ongoing COVID-19 pandemic and the stark reality that there are profound inequalities in global access to vaccines that require urgent global attention. With no one safe until everyone is safe, not only did we pause to express our sincere concern on the news from India on the status of the pandemic, we recognized the major interconnectedness of the growing inequality in vaccine access and food security, with nearly 300 million people in an unacceptable situation with regards to access to safe, nutritious food. We were resolute that 'the time is now' for CGIAR to be part of the solution.

It is significant that 2021 is CGIAR's 50<sup>th</sup> anniversary year, and we are reminded that global problems are now known to be more complex and interrelated than perceived to be in 1971. Importantly, it is the moment to rise to the challenge of demonstrating the essential need for CGIAR as One CGIAR – a bolder and more operationally integrated institution – we are a stronger global, regional and local partner, and at the forefront of creating solutions.

SC13 was also held against the backdrop of the energy growing around September's 2021 UN Food Systems Summit. The System Council recognized the efforts of so many of its members engaging proactively throughout their institutions to ensure that the UNFSS presents CGIAR with a powerful stage upon which to showcase how, as One CGIAR, we are ready to move the global agenda forward.

Contextual framing of the critical need for CGIAR to continue to implement our change agenda in an increasingly climate-challenged context was expertly provided by remarks from [Dr. Shakuntala Thilsted](#). We congratulated Dr. Thilsted as the 2021 World Food Prize laureate, honored for her contribution to improving the quality, quantity, and availability of food in the world through her pioneering scientific work on nutrition, fish, and aquatic food systems. We commended the fact that this year's award to Dr. Thilsted, an active CGIAR staff member and whose work was carried out in the context of CGIAR research, represents the 25<sup>th</sup> time that an individual directly associated with CGIAR has been recognized by the World Food Prize in the award's nearly 40 years existence.

We also heard from [Dr. S.M. Bohktiar](#), Executive Chairman of the Bangladesh Agricultural Research Council, on the importance and impact of this work on the lives and systems in his

country, reinforcing the value of country-level and collaborative processes that start with the consumers in mind.

We congratulated the three new Science Group Directors<sup>2</sup> on their appointments as part of the One CGIAR broader leadership team. For the first time, all CGIAR science and scientists will be brought together in three One CGIAR Science Groups under their leadership, and we recognized these appointments as a key step in establishing a fully integrated operational structure of One CGIAR.

Our deliberative sessions resulted in:

- **Resoundingly positive support for the [‘2022-2024 Investment Prospectus’](#) to be taken forward for development of an initial set of CGIAR Initiatives.** Through deliberations, it was acknowledged that at this stage of the work being undertaken to design the research initiatives to be funded during 2022-2024, ‘Investment Prospectus’ (rather than ‘Investment Plan’) better defined the evolving nature of that work. It was agreed that reframing the document in that way empowers the EMT and Science Group Directors to continue to rationalize, prioritize and refine the science of the prospectus in order to ensure a coherent and compelling portfolio. Commending the significant staff, management and partner time invested to reach this key moment in the design process, System Council members provided rich insights to assist in shaping and strengthening the research initiatives as they are developed. We took note of and appreciated the clarity of messaging from our Independent Science for Development Council on areas to strengthen the prospectus of research initiatives, and areas to watch for as work progresses. The offer for the System Council to receive periodic updates on the ongoing development of the initial initiatives, and further opportunities for engaging with the process, was welcomed.
- **Re-confirmation of the importance of the Funder side of the ‘grand bargain’ – and readiness to provide continued, more, and more pooled funding.** Many affirmed the important need to keep an equal focus on this goal as one of the 5 interconnected System Reference Group recommendations, as a key enabler of CGIAR’s delivery of 2030 Research and Innovation Strategy, recognizing the major internal transformation that Funders have strongly called for, and which is well underway, so that CGIAR operates and presents itself to its global, regional and local partners as an operationally integrated institution. Even at a time when funding is heavily strained due to the ongoing pandemic, there were important positive funding signals, including from some of the country partner members of the System Council. Members from the ‘Funder Champions’ group urged colleagues and all those involved to keep working to realize the important target of CGIAR growing its funding toward a \$2 billion annual institution, to effectively implement One CGIAR, as well as ensure funding for the 2022-2024 research initiatives investment period.<sup>^</sup>

- **Approval of additional members of CGIAR's Independent Science for Development Council, confirmation of a further term for the Chair of our Standing Panel of Impact Assessment as well as new SPIA membership, and an extension to the terms of members of our Assurance Oversight Committee.** Most of these appointments were women, with more women in attendance at SC13 as System Council members or alternates than before.
- **Unequivocal messages from System Council members on the much-needed outcome of CGIAR's internal reforms** relating to SRG recommendation no.2, unified governance and the 'checklist' of required changes to governing instruments and how boards work that was developed through the Transition Advisory Group process. There was unanimous emphasis on the need for all Center/Alliance Boards to adopt unified governance to the full extent permitted by hosting agreements and national laws, and take the required decisions to create the necessary enabling and authorizing environment for an empowered leadership team to further transform CGIAR's internal operating structure. While recognizing that change is inherently challenging, System Council members reiterated the connection between the fullest adoption of unified governance as is legally possible and forward-looking funding pipelines. Equally strong in this call for moving swiftly forward, were the voices of many of CGIAR's partner country constituencies, with strong messages of support for operating as one.

We also benefited from a 'highlights' session on the importance of CGIAR being a learning organization and leveraging valuable lessons from impact assessment, evaluation, and previous research programming to support future work and to verify the value of investment. System Council members confirmed both the appetite and need for more in-depth conversations on these key topics in future sessions.

As I close this Chair's summary – I wish to thank System Council colleagues for once again demonstrating our collective ability to hold open and honest discussions and use these to agree clear actions to move CGIAR forward. I recognize the challenges inherent in the continued virtual meeting format and thank all those involved for their tireless efforts to make our meetings as collegiate and fruitful as possible. I remain hopeful that we may be able to meet in-person by year-end, as we continue this important journey to transform CGIAR to meet the world's challenges ever more effectively.

### **DECISIONS**

#### SC/M13/DP1: Meeting Co-Chair

The System Council **appointed** Jim Barnhart, representative from USAID as the non-voting honorary Co-Chair for the meeting, pursuant to Article 5.2 of the CGIAR System Framework.

- b. **Took note** of the process going forward, in which the Investment Prospectus and its set of Initiatives will be adaptively managed by the Executive Management Team, advised by the Investment Advisory Groups that are chaired by the Global Science Group Directors.

#### SC/M13/DP5: Standing Panel on Impact Assessment membership

The System Council:

- a. **Appointed** Dr. Sujata Visaria as SPIA Standing Panel Member for a three-year term with effect 1 July 2021 unless otherwise decided by the System Council.
- b. **Appointed** Dr. Monica Biradavolu as an additional Special Initiative Member for a three-year term with effect 1 July 2021 unless otherwise decided by the System Council.
- c. **Extended** Dr. Karen Macours as current SPIA Chair for the remaining two years of the allowable six years until 30 September 2023.
