
<u>Purpose</u>: This document sets out the background and rationale for a proposed extension for the terms of:

** Special notice on 'Consent Agenda' status of this document **



Membership matters - Strategic Impact, Monitoring and Evaluation Committee (SIMEC)





1. Background: SIMEC Membership at 30 November 2021

- The System Council's Strategic Impact,
 Monitoring and Evaluation Committee
 ('SIMEC') was formed in 2017, at SC4, with
 Terms of Reference which provide for a
 maximum nine persons.
- The initial terms of members, appointed in 2017, was for a period until 30 June 2019, and extended at SC7 to 31 December 2020.
- At end-2020, membership terms were extended to 31 December 2021, with terms of new members joining in 2021 aligned to that date.
- Alan Tollervey took up the role of interim Chair at end-May 2021.

2. Basis of recommendation to extend terms until 30 June 2022

Rationale for extension and timing

 The current members continue to be active participants in SIMEC; are well linked into the voting member constituencies of the System Council they represent; and bring relevant experiences and skills for the tasks.

On timing out to 30 June 2022:


- The previous extension decision anticipated work during 2021 to take stock of the broader needs for assurance and oversight in the One CGIAR landscape and on what optimal mechanisms could look like for the future early discussions have commenced but are anticipated to be explored more fully in the first half of 2022.
- The functions carried out by SIMEC are needed into 2022 until any further changes are agreed.

Extension permissible under Article 13 - SIMEC Terms of Reference

• All members (including the interim Chair) can have their terms renewed as determined by the System Council. This extension proposal is in line with that Article.



Membership matters - System Council Intellectual Assets Group (SC IP Group)





SC IP Group: Background to recommendation

- The <u>CGIAR Principles on the Management of Intellectual Assets</u> ('CGIAR IA Principles'), which <u>established</u> and sets out terms of reference for the System Council's Intellectual Property Group (SC IP Group), is an important continuing policy of the CGIAR System.
- The SC IP Group has been discharging its duties in accordance with the TOR, including by:
 - annually reviewing all Center reports on the implementation of the CGIAR IA Principles during the preceding year, requesting further information as required, and providing any comments, concerns or recommendations as relevant to the System Organization; and
 - reviewing, and drafting an independent section of the annual CGIAR Intellectual Asset Management Report developed by the System Organization in consultation with the Centers
- The two persons whose membership terms are proposed to be extended have demonstrated expertise and practical experience in the management of intellectual assets and intellectual property rights and have effectively delivered during the reporting cycle for the 2019 and 2020 CGIAR Intellectual Asset Management Reports.
- Continuity in membership for a term to cover the 2021 reporting cycle is proposed, which will also provide opportunity for further informed discussion and consultation to explore the optimal role and arrangements for the SCIP Group in the One CGIAR context.
