Background of Quality of Research for Development (QoR4D)

Intent

- Developing research strategies and programs that deliver on CGIAR's mission
- Building a contemporary research portfolio
- Establishing rigorous monitoring and reporting systems
- Designing transparent performance management standards

Elements

- Relevance
- Scientific credibility
- Legitimacy
- Effectiveness

QoR4D for External Initiative Assessments: Lessons Learned



Approach

- Survey for external proposal subject matter experts (N = 53; 64% response rate)
- Consultations with internal leadership and scientists:
 - the director of programs,
 - global science directors,
 - the managing director,
 - research delivery and impact, and
 - three Initiative proposal leads from the Initiative Design Teams (IDTs).

Quality of Research for Development (QoR4D) & ISDC Workstreams

Comparative Advantage

Based on a consistent comment across the ISDC review of initiative proposals,

ISDC has developed a framework to provide an evidence-based approach to determining CGIAR and its research entities' CA.

Inclusive Innovation

One of the four elements of QoR4D is legitimacy.

For CGIAR inclusivity is imperative to ensure that “the research process is fair and ethical and perceived as such.”

Science Forum

The 2022 Science Forum events at TropAg and FAO examined two elements of innovation:

inclusion and institutions.

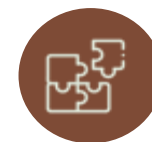

One CGIAR support →

2023 Work Plan: One CGIAR support – science for development advice provided for arising needs

- Changing needs for science advice in One CGIAR governance (science advice to System Board topic)
 - ISDC first line of accountability remains to SC; all advice is shared with Board and Management
 - ISDC can be available for periodic (quarterly TBD) ISDC group interaction with Board, depending on SC and Board request
 - Board ought to use CG's scientists as a key source of science information
- Coherence of CGIAR pooled research portfolio (review annual initiative reports topic)
 - ISDC can be available to review portfolio coherence based on Type 3 reports (annual, portfolio level) and Type 2 reports (triennial, portfolio level) depending on report templates and SC request
- An eye on transdisciplinary capacities (new STRIPE review ask)
 - Rather than head counts, attend to how teams are assembled and work together
 - ISDC questions whether a revamped STRIPE social science review needs to be an independent exercise
