Overview

1. CGIAR's [Technical Reporting Arrangement](#) was endorsed by the System Council's Strategic Impact, Monitoring and Evaluation Committee (SIMEC) during its 25th meeting on 10 June 2022.
2. The Technical Reporting Arrangement was co-developed by a SIMEC-endorsed Task Team comprised of System Council members and CGIAR Staff. It details the set of common reporting parameters that will satisfy the essential needs of all System Council members, and clearly measure achievements against the CGIAR Results Framework and planned results of the Initiatives and Impact Area Platforms.
3. The bulk of 2022 Portfolio Technical Reporting aligned to the Technical Reporting Arrangement is now in hand, notably:
 - a. 31x Initiative 'Type 1' Annual Technical Reports on Progress towards End of Initiative Outcomes
 - b. 1x Gender Equality, Youth and Social Inclusion Impact Area Platform 'Type 1' Report on progress against Four Key Functions
 - c. 1x CGIAR Portfolio Performance Management and Project Coordination Practice Change 'Type 3' Report
 - d. 1x online Results Dashboard

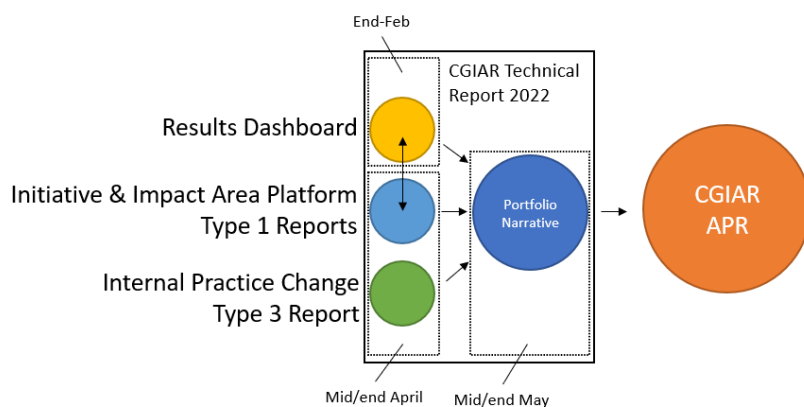


Figure 1 The 2022 Technical Report comprises the Results Dashboard, Initiative and Impact Area Reports, an internal Practice Change report, and the Portfolio Narrative. These will be integrated into CGIAR's Annual Performance Report (APR) due in September.

5. The 2022 Portfolio Narrative will be released around end-May. It is the final piece of the 2022 Technical Report (see Figure 1) and will provide an aggregate, portfolio-level overview of Portfolio progress and coherence, provide a select number of common threads highlighting key One CGIAR stories, and demonstrate overall progress in CGIAR's approach to performance and results management.

6. In the lead-up to the release of the Portfolio narrative around end-May, this System Council session will provide an advance look at aggregate progress measures and highlight emerging insight from the Portfolio performance and results evidence submitted in the 2022 Technical Report.
