SB/M27/EDP7	Governance	 Whereas: The CGIAR Integration Framework Agreement (as fully executed between all Parties on 21 February 2023) provided, in Article V, 5, that an independent review of the unified governance arrangements will be carried out in 2023; and The outcomes of that independent external review, overseen by the Ad Hoc Committee on Governance, have been translated through a consultative process into a set of proposals by a Drafting Working Group drawn from across the IFA Parties and the System Council – in the form of the "CGIAR memorandum on the implementation of governance recommendations"; Now therefore, the CGIAR System Board: Endorsed the "CGIAR memorandum on the implementation of governance recommendations"; Approved the package of proposals set out therein; Committed to working in good faith to implement these proposals to achieve the Integrated Partnership by the dates set out in the memorandum; and Requested that the Board Secretary, in consultation with the Board Secretaries Community of Practice and Legal Teams, prepare proposed changes to the Charter of the CGIAR System Organization (and any other governing document where amendments would be required to implement the proposals) for the Board's review and decision-making. 	13 December 2023

SB/M27/EDP9	Evaluation	The Charter of the CGIAR System Organization (at Article 8.1 rr) provides that the System Board's role in relation to evaluations is to "review external independent evaluations of the CGIAR Portfolio, functions and structures and provide comments to the System Council for its consideration". The System Board reviewed the evaluation report and CGIAR's management response and reflected that the management response is appropriate. The Board also noted that the evaluation report contained 11 recommendations with many sub-recommendations for which a prioritization would have been helpful. Without such prioritization, it is more difficult to assess if timelines are appropriate for achieving results. It was also noted that some recommendations focus on actions instead of results which makes it unclear how they will contribute to improvements.	9 February 2024
