CIC Member Portal Terms of Service

Welcome to the CIC Member Portal! CIC is excited to offer you this opportunity to learn more about the CIC community and to connect with other community members. These terms of service (the "Terms") govern your use of the Portal and define our rights and obligations. By clicking "I agree," you are committing yourself to be bound by these Terms, including by updates and revisions to the Terms as described below. If you disagree with these Terms, you must not use the Portal.

These Terms apply to CIC and its current and future affiliates (collectively, "CIC") and to current and future CIC clients and their members and employees, including you (collectively, "Portal Users").

Your Use of the Portal and Directory

Portal Users must be at least 18 years of age, and by clicking "I agree," you are representing that you are at least 18 years of age.

Portal Users may access the Portal by creating password-protected accounts. You may not disclose your password to anyone else or let any other person use your account, even if that other person is your employee or is a member of the CIC community.
