# **Approval of April 18, 2024 Special Meeting Minutes**

#### **Financial Overview**

Ms. Anderson gave an overview of the five-year forecast, discussed the historical funding methodology of the Commission, provided the history of the funding between the schools, and provided two different scenarios to showcase the different results of using an average daily membership as an allocation basis versus going by priority.

# Discussion and Consideration of New Funding Requests Received and Presented at April 18, 2024 Meeting for Fiscal Year 2025

The Commission members asked questions regarding the projects, whether the requested amount could be lowered, and discussed among themselves to come to a census on which projects to approve. Commission Member Amanda Simpkins made a motion to recommend \$15,344,157 worth of projects (Asheville City Schools: \$2,484,157; Buncombe County Schools: \$12,860,000). Commission Member Amanda Edwards seconded. The motion passed unanimously. The breakdown of the recommended projects is:
