Commissioner Sloan called the meeting to order at 10:01 am.

Motion to approve the April agenda and the March meeting minutes passed unanimously.

Public Comment:

Brad Rouse: Encourages subcommittee to provide funding support to achieve 100% Renewable Energy Goal (Community-wide). Lack of capital for ESN to do multiple projects at one time- need for a revolving fund. Wants to see BHP adopt 100% clean energy (as opposed to "renewable energy) because it is more aligned with federal government and utility and allows for nuclear power.

New Member Introductions:

- Introductions of other Subcommittee Members and support staff
 - o Josh LittleJohn: Background in energy efficiency and renewables
 - o Bob MacDonald: Retired USDA- Background in agriculture research and government

Clean Water Fund Allocations

- \$100K available
- 3 proposals submitted
 - o Asheville Greenworks (\$35K) Trash Trout
 - Town of Black Mountain (\$100K)
 - o RiverLink (\$50K) Disconnect to Protect
 - o Staff had ranked projects: 1. RiverLink, 2. Town of Black Mountain, 3. Greenworks
- Subcommittee discussed multiple scenarios to partially fund multiple projects:
 - o Scenario 1:
 - Town of Black Mountain could move forward with \$75K
 - Greenworks \$7500 for the actual trash trout
 - RiverLink could support ~35 households for \$17,500
 - Scenario 2:
 - Fund Riverlink at \$50, Town of Black Mountain at \$75
 - \$25K coming from next Clean Water Fund Grant cycle contingent on approval
 - Scenario 3:
 - Fund Black Mountain at \$75K and RiverLink at \$25K

- Commissioner Wells made motion to fund this scenario. Motion passed unanimously.
- Staff will encourage RiverLink to reapply for remainder of funding next year

GreenBank Loan Loss Reserve Update- Michelle Myers, NCCEF Program Manager

- o Electrify Asheville Buncombe (E-ABC) had soft launch last week- still finalizing web presence
- o E-ABC overview
 - o Program to support residents getting high efficiency heat pumps into their homes
 - Heat pumps is where you get the most bang for your buck when switching to high efficiency technology
- NCCEF Financing package in partnership with Self-Help Credit Union
 - o Requires vetted technologies and licensed contractors
 - o Financing is critical to close gap between conventional and high efficiency
 - Goals: Connect contractors and consumers with financial and incentive providers including tax credits, POS rebates, and unique loan option from Self-Help
- Leveraging the Loan Loss Reserve
 - More inclusive- accepts applicants with credit scores 550+
 - o Interest rate discount
 - o Pushing Self-Help to offer a similar financing option across the state
- Loan Overview
 - o 2.99% admin fee goes to NCCEF
 - Subcommittee asked NCCEF to see what it would take to cover that fee
 - o Loan amounts of \$2.5K-\$50K
 - o 5, 10, 15 yr loan terms (no penalty for paying off early)
 - o Fixed interest rate (5.5-9%) reassessed every 6 months
- Conservation pros doesn't have a financing option- so this will allow them to offer financing for the first time for insulation services
- o BrightSpaces, GBA, County CAPE team will help with outreach
- o Update on NCCEF/ GHG Reduction Fund
 - NCCEF is currently funded through philanthropy but their business plan also includes fees for work and program income from GHG reduction fund capital
 - GHG reduction funds will be awarded to national intermediary teams
 - NCCEF expects to access up to \$10 million in the short term for products they are building including bridge loans for non-profits
 - Hope to have access to capital in fall of 2025
 - Solar for all allocation will be announced next week
 - State has not given NCCEF any money

- o Fire Departments (10 projects) going out to bid-hoping for operation dates in early Dec
- Field trip to solar canopy on 200 College Deck
