Vehicle Allocation

- Going over requirements for Transfer and Disposal of Equipment Purchased with JCPC Funds for Buncombe Structured Day
 - Section 7, Subsection A triggered by Buncombe Structured Day program not being funded by JCPC

- Match Rate of 30%, \$11,000 was invested at point of purchase
- Decisions will need to be made today regarding the vehicle allocations
 - Requests for the vehicle sent to the JCPC by UMOJA/UNETE and Aspire Youth and Family Programs, and by the Buncombe Structured Day Program to either keep the vehicle since they will be continuing to serve youth as a non-JCPC program OR to receive their 30% match back for the purchase of the vehicle in spring 2023.
 - UMOJA/UNETE-Will receive funding come July 1st
 - During the school year 75 youth served and during the summer program 40 youth with more to come in July
 - UNETE serving 72 youth
 - Transfer to come after July 1st
 - Aspire-Kids at Work program
 - 2-3 times a week classes teaching culinary skills
 - Promised to serve 36 with a waitlist of 6 waiting to get into the program
 - One van being used since their first van was sent to salvage
 - Having to provide mileage to staff
 - Current van seats 6 youth, 2 staff members
- o Motion for UMOJA/UNETE to get the van from Buncombe Structured Day
 - 1^{st-}Angel Redmond
 - 2nd-Banta Whitner
