A description of where the material that you claim is infringing is located on the Services, with enough detail that we may find it on the Services;

Your address, telephone number, and email address;

A statement by you that you have a good faith belief that the disputed use is not authorized by the copyright or intellectual property owner, its agent, or the law; and

You agree to defend, indemnify, and hold harmless Civian and/or Ichor Strategies, its affiliates, licensors, and service providers, and its and their respective officers, directors, employees, contractors, agents, licensors, suppliers, successors, and assigns from and against any claims, liabilities, damages, judgments, awards, losses, costs, expenses, or fees (including reasonable attorneys' fees) arising out of or relating to your violation of these Terms of Use or your use of the Website, including, but not limited to, any use of the Website's content and Services other than as expressly authorized in these Terms of Use or your use of any information obtained from the Website.

#### 20. Disputes

The Federal Arbitration Act ("FAA") and AAA Rules shall preempt all state laws to the fullest extent permitted by law. If the FAA and AAA Rules are found to not apply to any issue that arises under these Terms of Use or the enforcement thereof, then that issue shall be resolved under the laws of the State of New York.

There is no judge or jury in arbitration, and court review of an arbitration award is limited. However, an arbitrator can award on an individual basis the same damages and relief as a court (including injunctive and declaratory relief or statutory damages), and must follow the provisions of these Terms of Use as a court would. The prevailing party in arbitration will be entitled to an award of attorneys' fees and expenses, to the extent provided under applicable law. To begin an arbitration proceeding, you must provide Civian and/or Ichor Strategies with a written Demand for Arbitration as specified in the AAA Rules. Payment of all filing, administration and arbitrator fees will be governed by the AAA's rules.

If for any reason a claim proceeds in court rather than in arbitration you waive any right to a jury trial. You additionally agree that you may bring claims against us only on an individual basis and not as a plaintiff or class user in any purported class or representative action or proceeding. Unless we agree otherwise, the decision-maker may not consolidate or join more than one person's or party's claims and may not otherwise preside over any form of a consolidated, representative, or class proceeding. Also, the decision-maker may award relief only to the extent necessary to provide relief necessitated by that party's individual claims. Any relief awarded cannot affect other users.

# 22. Governing Law and Jurisdiction

By using the Website or our Services, you agree that the Federal Arbitration Act, applicable federal law, and the laws of the State of New York, without regard to principles of conflict of laws, will govern these Terms of Use and any dispute of any sort that might arise between you and Civian and/or Ichor Strategies.

#### 23. Limitation on Time to Initiate a Dispute
