- 1 Strike everything after the enacting clause and insert the 2 following:
- 3 "NEW SECTION. Sec. 1. A new section is added to chapter 69.50 4 RCW to read as follows:
- 5 (1) A licensed cannabis producer and a licensed cannabis 6 processor may sell cannabis waste to a person not licensed under this 7 chapter if:
- 8 (a) The cannabis waste would not be designated as dangerous or 9 hazardous waste under:
  - (i) Chapter 70A.300 RCW and rules adopted under that chapter; and
- 11 (ii) Cannabis waste disposal rules adopted by the board;
- 12 (b) The licensee notifies the board and the Washington state 13 department of agriculture before the sale. Such notice must include 14 information about the quantity and sale price of cannabis waste 15 transferred and the name of the person or entity that purchased the 16 cannabis waste; and
- 17 (c) The licensee makes all sales available to the public on an equal and nondiscriminatory basis.
  - (2) Cannabis waste not sold in accordance with subsection (1) of this section and not designated as dangerous or hazardous waste under chapter 70A.300 RCW, rules adopted pursuant to that chapter, or cannabis waste disposal rules adopted by the board must be rendered unusable before leaving a licensed producer, processor, or laboratory.
  - (3) For the purposes of this section, "cannabis waste" means solid waste generated during cannabis production or processing that has a THC concentration of 0.3 percent or less. "Cannabis waste" does not include "hemp" or "industrial hemp" as those terms are defined in RCW 15.140.020.
- 30 (4) Nothing in this chapter prohibits producers or processors 31 from selling cannabis waste to a person not licensed under this

- 1 chapter if such transfer is pursuant to the requirements of this
- 2 section.
- 3 (5) The board may adopt rules necessary to implement this
- 4 section."
- 5 Correct the title.
  - <u>EFFECT:</u> (1) Requires licensed cannabis producers and processors to comply with the following requirements to sell any cannabis waste:
  - (a) Include information in the notice provided to the Liquor and Cannabis Board and Department of Agriculture about the quantity and sale price of the cannabis waste and the name of the entity that acquired the cannabis waste; and
  - (b) Make all sales of cannabis waste available to the public on an equal and nondiscriminatory basis.
  - (2) Clarifies that nothing prohibits cannabis producers and processors from selling cannabis waste to a person who is not licensed by the Liquor and Cannabis Board if certain requirements for the transfer are satisfied.
