I hope this finds everyone doing well. The Liquor and Cannabis Board is requesting your feedback, suggestions, or any comments you may have on potential draft legislation the LCB is considering requesting for the 2024 legislative session. Attached are three drafts of potential bill proposals the agency is actively considering at this time. One proposal relates to alcohol, and the other two relate to cannabis. Each proposal has a PDF summary, and you will find the draft language proposals are in Word format to be able to see proposed changes.

If you have any feedback for the agency that you would like us to consider before we make any final decisions on what proposed language to submit, **we will need to hear your thoughts by Friday, August 25, 2023 COB.**

This deadline will give the agency enough time to consider all comments and suggestions and hold internal discussions to determine potential revisions to these draft proposals. Our final proposals are due for submission to the Office of Financial Management and the Governor's office in mid-September.
