Driving Directions

Directions for coming from the north on I-5:

- Take Exit 165A toward JAMES Street.
- Continue STRAIGHT to go onto 6TH Avenue.
- Move immediately to the RIGHT lane and then turn RIGHT onto COLUMBIA Street. (As you approach Columbia Street and move into the right lane, be aware that cars are turning onto 6th on your right from Marion Street).
- Turn RIGHT into the building parking entrance from Columbia Street.

Directions for coming from the south on I-5:

- Take the MADISON Street exit from I-5.
- Turn LEFT onto Madison Street.
- Turn LEFT onto 5TH Avenue.
- Turn LEFT onto MARION Street.
- Turn RIGHT onto 6th Avenue.
- Turn RIGHT onto COLUMBIA Street.
- Turn RIGHT into the building parking entrance from Columbia Street
