PUBLIC COMMENTS ON AGENDA AND NON-AGENDA ITEMS

Lynn Boone, Compton resident, commented on the report, she requested at the November 24, 2009 meeting regarding the First Time Homebuyer and Residential Rehabilitation programs. Ms. Boone stated that she requested the report, due to the changes that took place in the Community Redevelopment Agency. Ms. Boone stated that the guidelines associated with both programs were amended, due to a report she submitted to the United States Housing of Urban Development. Ms. Boone stated that she does not want the citizens to fail from the benefit of the funds allocated to the city, therefore she referred them to the funding source. Ms. Boone conceded that citizens could not rely on elected officials to better the City of Compton.

Joyce Kelly, Compton resident, stated that she too, had inquired about the report that the Director of the Community Redevelopment Agency was supposed to submit, however she did not receive a copy. Ms. Kelly stated that she felt the information concerning housing assistance was not being distributed to the community and cited that more should be done for the homeless people living in the City of Compton.
