SUMMARY:

The Compton Public Finance Authority will consider adopting a Resolution that will revise the dates of the regular meetings of the Public Finance Authority of the City of Compton. This Resolution will rescind Resolution No. 13 and establish the regular meeting dates for the Authority as 2:45 p.m. on the second (2nd) and fourth (4th) Tuesdays of the month.

BACKGROUND:

Pursuant to the Joint Exercise of Powers Law (Articles 1 through 4, commencing at Section 6500 of Chapter 5, Division 7, Title 1 of the California Government Code), on November 10, 1987, the City Council of the City of Compton adopted Resolution No. 15,353, and the Urban Community Development Commission adopted Resolution No. 927, which authorized the City of Compton and the Urban Community Development Commission, acting as the Community Redevelopment Agency of the City of Compton to create the Compton Public Finance Authority.

Subsequent to the formation of the Compton Public Finance Authority, on November 17, 1987, the Board of Directors of the Compton Public Finance Authority adopted Resolution No. 1, which approved and adopted By-Laws of the Compton Public Finance Authority. Section 4 of Article II of the Compton Public Finance Authority By-Laws establishes that regular meetings of the Authority shall be held at such time as the Board may fix by resolution.

On August 1, 1989, the Compton Public Finance Authority adopted Resolution No. 13, which established the regular meeting times for the Authority at 2:45 p.m. on the second (2nd) and fourth (4th) Tuesdays and at 6:45 p.m. on the first (1st) and third (3rd) Tuesdays of the month.
