The Urban Community Development Commission meeting was called to order at 3:41 p.m. in the Council Chambers of City Hall by Chairperson Pro-Tem Yvonne Arceneaux.

PUBLIC COMMENTS ON AGENDA AND NON-AGENDA ITEMS

Lynn Boone, Compton resident, commented on the answers she received, in regards to the LINC Housing Project for senior citizens. Ms. Boone also made reference to the proposed residential projects in the community, the demolition of the Martin Luther King, Jr. Transit Center and the proposed Senior Community Center. Ms. Boone urged the citizens to ask questions and think about the future of Compton.

Joyce Kelly, Compton resident, apologized to Chairperson Pro-Tem Arceneaux for her behavior during the February 2, 2010 meeting and affirmed that she is entitled to a copy of the extended agenda booklet, in accordance to the Brown Act. Ms. Kelly went on to speak in opposition to the employment of consultant firms for the Community Redevelopment Agency and city public relations services.

William Kemp, Compton resident, issued a letter of no confidence to the Executive Secretary and requested his resignation.

COMMISSION COMMENTS

Commissioner Calhoun asked the Executive Secretary if he was aware of State of California's mandate of municipalities to construct a percentage of low-to-moderate income housing and senior housing facilities.

Charles Evans, Executive Secretary, replied affirmatively and added that all cities, especially those cities receiving Community Redevelopment Block Grant funds are required to set aside twenty percent of their housing stock to low-to-moderate housing residents. Mr. Evans indicated that the city is behind on this mandate and is currently trying to meet the goals of the State of California.

Commissioner Calhoun questioned what would happen in the event, the city does not meet the requirements set by the State. Mr. Evans stated that the city could be fined, in addition to the seizure of redevelopment assets.
