- Guests booked on Shuttle flights, are not guaranteed to be on the same aircraft, however Federal Airlines will do all possible to assist familie/groups in travelling together, subject to operational requirements.
- Departure & Arrival Times may vary depending on actual lodge and guest requirements as well as landing conditions. Early departure from lodge/s may be necessary to accommodate lodge hopping.
- Luggage is restricted to 20kgs [44 lbs] per person - Please note that OR Tambo International Airport have adjusted their baggage policy **referencing irregular shaped bags**. In line with this, **Federal Airlines have adjusted our baggage policy to allow bags that contain one flat or rigid side**.
- Rates subject to airfield suitability, availability/noise abatement and operational procedures. Aircraft landing and/or departure may be delayed due to animals obstructing the runway.
- Confirmed bookings are subject to automatic release if passengers' full names are not received at time of confirmation.
- FederalAir reserves the right to include technical stops en-route due to operating conditions in the interest of safety and at the sole discretion of the captain.
- Late Guest arrivals will be booked on next available flight [Possibly following day]. Cancellation Fees may apply.
- FederalAir cannot be held liable or responsible should incoming flights be delayed resulting in passengers missing their shuttle connection to the bush.
- FederalAir cannot be held liable or responsible for any delays due to weather, resulting in missed connections when returning from any lodge.
- **Delays due to Weather and Air Traffic Control [Arrival or Departure] are beyond our control. Travel Insurance is advisable.** • In the event of bad weather (low cloud or waterlogged runways) FederalAir reserves the right to drop off clients "at the nearest suitable and serviceable airstrip". This may result in a road transfer to enable guest's arrival at their destination. Such road transfer will not be for Federal Airlines' account, however for the guests' account. Such diversion will only be done in the interest of safety and when weather and / or runway conditions are not suitable to land at the original destination.

#### Airstrip / Passenger Taxes

- Should private planes park overnight at Thornybush Airstrip the fee is R 750.00 per day (payable direct upon check out or at Thornybush Game Lodge).
- Should private planes park overnight at Simbambili/Arathusa the fee is on request (payable direct upon check out).
- In the case where Thornybush Luxury Game Lodge Collection book flight services, applicable taxes are included in the quoted rate unless otherwise specified.
- *In the case where agents/guests book flight services directly with FederalAir or alternate airlines (not FederalAir) the charges will be collected directly at the lodge.*
- *Agents/Guests wishing to include these costs should please indicate at time of booking.*

#### In order for Thornybush to book Federal Air Charter Flights, we will require the following:

- In order to comply with international insurance requirements, all airline tickets must clearly show the passenger's title, name and surname (as indicated in their passport).
- The airline does require all inbound and outbound flight numbers, arrival/departure times as well as any other important information at time of booking.
- The air fare and airport tax quoted are current and are subject to change *without prior notice* should the airline impose an increase for any reason. Fares and taxes may increase between time of making a reservation, time of payment and time of travel. Any additional fees will be for the Guests account.
- Confirmed bookings subject to automatic release if passengers' full names are not received at time of confirmation.
- The Thornybush Collection cannot be held responsible should airlines discontinue flights, change scheduled timetable resulting in missed connections or increase fares.
