AGREED RESPONSE TO SOAH ORDER NO. 3

I. INTRODUCTION

Southwestern Public Service Company ("SPS") respectfully submits this Agreed Response to SOAH Order No. 3 on behalf of all parties to this proceeding, including Staff of the Public Utility Commission of Texas, the Office of Public Utility Counsel, Texas Industrial Energy Consumers, Golden Spread Electric Cooperative, Inc., IBEW Local Union 602, the Alliance of Xcel Municipalities, and Walmart, Inc. (collectively, the "Parties"). On January 23, 2025, the State Office of Administrative Hearings ("SOAH") Administrative Law Judge ("ALJ") issued SOAH Order No. 3, which requires SPS to file: (1) an agreed proposed procedural schedule by January 31, 2025, and (2) a statement as to whether the parties request a referral to mediation. The Parties have authorized SPS to present the SOAH ALJ with their agreements on these issues, which are embodied in sections II and III below.

II. AGREED PROPOSED PROCEDURAL SCHEDULE

The Parties agree to the following proposed procedural schedule (the "Agreed Proposed Procedural Schedule"), which satisfies the requirements specified in SOAH Order Nos. 1 and 3. The Agreed Proposed Procedural Schedule also includes other agreements addressing modified timelines for discovery responses, the discoverability of certain materials, and the submission of hearing exhibits. The Parties respectfully request that the SOAH ALJ issue an order adopting the Agreed Proposed Procedural Schedule, including their other agreements.

Other Agreements

- 1. Discovery Deadlines on Applicant Direct (for discovery served after the Parties file an agreed procedural schedule):
 - a. Responses are due 10 calendar days after service
 - b. Objections are due 7 calendar days after service
 - c. Motions to compel are due 5 business days after objection
 - d. Responses to Motions to compel are due 5 business days after motion
- 2. Discovery Deadlines on Staff/Intervenor Direct, Applicant Rebuttal, and Staff/Intervenor Cross-Rebuttal:
 - a. Responses are due 3 business days after service
 - b. Objections are due 2 business days after service
 - c. Motions to compel are due 2 calendar days after objection
 - d. Responses to motions to compel are due 2 calendar days after motion, or live at the hearing
- 3. Discovery requests received after 3:00 p.m. (CT) will be considered received on the following business day.

- 4. Cross-examination exhibits shall be submitted no later than 7:00 p.m. (CT) on the day(s) before each day of the hearing that the party anticipates using the exhibits.
- 5. Drafts of testimony and emails conveying drafts of testimony are not discoverable.

III. STATEMENT REGARDING MEDIATION

The Parties have discussed whether a joint request for mediation is appropriate for this proceeding and agree that they will *not* request a referral to mediation.

IV. <u>CONCLUSION</u>

On behalf of the Parties, SPS respectfully requests that the SOAH ALJ issue an order adopting the Agreed Proposed Procedural Schedule, including the Parties other agreements. SPS is authorized to represent that no Party opposes this request.
